
MEMORANDUM

It has come to the notice that while uploading the data of vacancies of the flat Type-I to III, the area AE/JE are not uploading the complete vacancies of the flat available in their respective area in the e-Awas system. They are also not sending the vacancy of some of vacant and habitable flats to PWD Secretariat, Allotment Branch, for the uploading of the same in the system.

Keeping habitable vacant flats un notified from the public domain and from bidding is a bad practice on the part of concerned AE/JE. As it keeps the eligible applicants away from bidding these flats which also defeat the very purpose of bidding of all PWD vacant flats through e-Awas system.

It is therefore informed to all concerned AE/JE that henceforth no habitable vacant flat should remain unnotified from the Public domain for eligible bidders.

Therefore, in view of the aforesaid facts, as well as in the interest of the Government Revenue all concerned area AE/JE are hereby directed that henceforth, they will ensure that the all vacancies of the habitable Govt. Flats is either timely uploaded in the e-Awas system at their level and soft copy of the same is sent to this secretariat's allotment branch or vacancy reports in hard copy under their signature with a undertaking that all habitable vacant flat are being notified. This report should reach invariably by 25th of every month. Non compliance on the part of the area AE/JE would be viewed seriously.
