**Minutes of meeting convened on 19-03-2015 at 11:00AM**

A meeting was convened of the Medical Committee consisting of following members on 19-03-2015 at 11:00 AM in the Conference Hall of PWD Secretariat, 5<sup>th</sup> Level, B-Wing, Delhi Secretariat to consider the application for allotment of Government Accommodation on the basis of Notification dated 21<sup>st</sup> November 2014, dealing with amendment in the Government of National Capital Territory of Delhi Allotment of Government Residences (General Pool) Rules, 1977, for allotment of Government Accommodation to the officials covered under the categories of (1) Persons with Disabilities, through inserting Sub Rule (3) in Rule 8 of aforesaid allotment Rules, & on (2) Medical Ground (of various diseases for self and dependent as mentioned in the aforesaid notification), by inserting amended Rules 20A(1) in the aforesaid allotment Rules.

During meeting the applications of all officials who have applied with the supporting medical documents of their disease in respect of Medical Cases and with Disabilities Certificate in respect of Persons with Disabilities category from Type-I to Type-IV in pursuance of this office letter of even no. Dated 7<sup>th</sup> January 2015, inviting such kind of applications were considered.

After issue of aforesaid notification dated 21<sup>st</sup> November 2014, the vacancies in respect of Type-I to Type-IV of Ground Floor flats in proportionate percentage area were kept for allotment to the aforesaid respective categories officials, in respect of all bidding done in category Type-I to Type-IV for General Pool allotment.



It was observed that **176, 87, 85 & 26** total vacancies of flat for allotment was offered for allotment through online bidding after issue of notification dated 21<sup>st</sup> Nov 2014 for Type- I to Type-IV and **04, 02, 02 & 01** no. of flats were kept for adhoc allotment on Medical Ground and whereas **05, 03, 03 & 01** no. flats were kept for allotment to Persons with Disabilities for Type-I to Type-IV respective Category.

After scrutiny of documents filled alongwith the applications in respective category, by the all Committee Members, the following cases were recommended for allotment on Medical Ground as well as to the Persons with Disabilities ground respectively. The applications of the official without/incomplete supporting medical documents through were considered but were rejected for want of supporting documents to check the nature/severity of the disease as should have been required in pursuance of the aforesaid notification.

The cases in which the applicants have filled their application supported by the requisite documents were recommended after scrupulously examining the documents of applicants on the basis of their Date of Priority/Date of Joining in Government Service.
