HODs are requested to depute concerned officer dealing with the issue of payment of wages to outsourced staff/employees to attend the aforesaid meeting on 11.04.2017 at 11:00 A.M. along with copy of directions so issued to the contractor/s for compliance.

As per data available with Labour Department, contractors have also been informed separately through a letter to attend this meeting, however, in addition to that HODs are also requested to instruct their contractor/s to attend the aforesaid meeting as per above given date and time.
