

विषय:- Exemption for Government building from operation of Municipal Laws to regulate their erection.

The North DMC vide their letter No. D-02/C.E.(Bldg.)/HQ/2017 dt. 18.05.2017 has exempted the PWD projects, to be used for public purpose, from seeking sanction of building plan from the local bodies as per provision of section-3 of Govt. Building Act 1899, subject to adherence to the norms of UBBL-2016/MPD-2021, as amended up-to-date as well as other rules/regulations/Acts/notification as applicable. However, they shall give reasonable notice to the local bodies i.e. concerned Zonal Building Deptt. as per provision to Section 3 of the act before erection of the Govt. Buildings.

In view of above, it has been decided to set up the following committee to examine all the drawings for PWD Projects to be used for Public Purposes under the Chairmanship of Sr. Architect, PWD:-

The above committee will examine all the drawings prepared and to certify that the buildings plans conform to the building by-laws, after assessing all the requirements of Electric Load, water-supply, sewerage and horticulture, based on input provided by the concerned Executive Engineer(Civil) & Executive Engineer(Elect.). The concerned Executive Engineer(Civil) will submit the proposal in complete shape to respective local bodies about proposed construction and all the records shall be maintained by concerned Executive Engineer(Civil). The Committee will secure all necessary approval from Fire Department, DUAC and other concerned applicable authorities like Airport Authority of India, National Monument Authority, Heritage Committee, Environment Clearance, etc.

OFFICE ORDER

Subject: Exemption of Government Buildings from operation of Municipal Laws to regulate their erection.

Corporation vide its Resolution no. 601 dated 14.03.2017 has resolved to allow PWD Projects, to be used for public purpose, exempt from seeking sanction of Building Plan from the Local Bodies, as per provision of Section-3 of Government Building Act, 1899, subject to adherence to the norms of UBBI-2016/MPD-2021, as amended up-to-date as well as all other rules / regulations / Acts/ notifications as applicable. However, they shall give reasonable notice to the local bodies i.e. concerned Zonal Building Deptt. as per provision to Section 3 of the Act before erection of the Government buildings.

They are further required to deposit the requisite charges as applicable, to the Local Body, alongwith the notice of commencement and after completion of the project shall obtain occupancy-cum-completion certificate from the Local Bodies.
