The Engineer-in-Chief, PWD pointed out that there is no progress/improvement in the maintenance works of PWD despite regular and repeated instructions to improve the maintenance of PWD, particularly, in the roads section. The instructions and minutes of the 1st Monday Review Meetings are issued for improvement in the maintenance works, but no concrete action has been taken by the field staff, particularly, in the following areas:

1. Greening of Roads:

Hon'ble Lt. Governor of Delhi has described that PWD roads are the face of the Delhi and greening on PWD roads should be at par with the green area maintained by DIAL at Air-port. Action Plan should be prepared to meet the expectation of the Hon'ble Lt. Governor.

2. Road Repairing Work:

Pot holes should be filled by Pot hole filling machine instead of manual repairing. Despite repeated instructions, no action has been taken in this regard. It was decided in the last

meetings that pot holes should be filled with automatic pot hole repair machine, but no action has been taken. There is a need for taking immediate action in this regard.

3. Improvement of Roads:

Wherever there is a need, the riding quality needs improvement along with repairs to the kerb stone, median, foot paths, road markings and corrections in the signages.

4. Sh. Surender Singh, Chief Engineer (Health) Maintenance has intimated that they have implemented mandatory bio-metric attendance for outsourced staff. But bio-metric attendance is not implemented in other offices for outsourced staff, despite clear and repeated instructions by this office. Henceforth, all attendance should be bio-metric attendance and payment for outsourced staff should be made on the basis of bio-metric attendance in all the offices of the PWD.

5. All the points mentioned in the last Minutes of the Meeting are to be complied by the concerned offices and compliance report of the same is to be submitted to this office.

This issues with the approval of the Engineer-in-Chief, PWD.
