

ORDER

No. F.7(7)/2013-14/DSCST/SCP/Vol-III/21235 .-In exercise of the powers conferred by section 18 of the "Prohibition of Employment as Manual Scavengers and their Rehabilitation Act, 2013" (25 of 2013), the Lieutenant Governor of the National Capital Territory of Delhi hereby authorises the Commissioners of all the three Corporations i.e. North Delhi Municipal Corporation, South Delhi Municipal Corporation, East Delhi Municipal Corporation and Secretary of New Delhi Municipal Council and Deputy Commissioners (Revenue) of all the eleven Revenue Districts to ensure that the provisions of this Act are properly carried out;

Further, the Commissioners of all the three Corporations i.e. North Delhi Municipal Corporation, South Delhi Municipal Corporation, East Delhi Municipal Corporation and Secretary of New Delhi Municipal Council and Deputy Commissioners (Revenue) of all the eleven Revenue Districts may, specify the subordinate officers, who shall exercise all or any of the powers, and performs all or any of the duties, so conferred or imposed, and the local limits within which such powers or duties shall be carried out by the officer or officers so specified.


