Pléase find enclosed above cited letter received from Labour Department, GNCTD on the subject matter vide which it is intimated that Building and other construction workers should be registered through same registering and recommendatory authority of the concerned establishment who could register the construction workers at their site and process the website claims of registered construction workers of that establishment and submit the same to DBOCW Board for disbursement of the same. It is also decided that Assistant Engineer may be notified as registering officer for registration of construction worker and Executive Engineer may be notified as recommednding officer for processing of the welfare claims of registered construction worker.

Minutes of the meeting with various departments on the issue of registration of construction workers in respect of their Establishment under BOCW Act,1996 held on 18.08.2017 under the Chairmanship of Secretary-Cum-Labour Commissioner.

1. The meeting with various departments on the above issue was convened and 11332 on 18.08.2017 under the Chairmanship of Secretary-Cum-Labour Commissioner, Labour Department, Government of NCT of Delhi. List of Commissioners who attended the meeting is annexed.

- 2. The Chair explained the objective and purpose of the meeting and informed the members that this meeting has been convened to discuss and deliberate upon the issues in respect of registration of construction workers under BOCW Act, 1996.
 - 3. The Additional Labour Commissioner informed the members about the provisions of BOCW 1996 especially in respect of registration process, registration fees and the benefits of various welfare schemes of Delhi Building and Other Construction Workers Welfare Board (DBOCW). He further informed the shortcomings in the present process of registration and role played by various trade unions connected with construction workers.

He further informed the members that some of the trade unions are indulging in unethical practices wherein non-construction related workers are certified as construction workers and get them registered with Delhi Building and Other Construction Workers Welfare Board (DBOCW). This practice is against the BOCW Act 1996 and Delhi Rules 2002.

In order to have smooth, better and transparent registration process and also for timely processing of claims it was suggested by Additional Labour Commissioner that registering and recommendatory authority may also be from the same establishment who could register the construction workers at their site and process the welfare claims of registered

construction workers of that establishment and submit the same to DBOCW Board for disbursement of the same. The suggestion was accepted by all the members. It was agreed by the members that the Assistant Ergineer may be notified as Registering officer for registration of cons ruction worker and Executive Engineer may be notified as recommending officer for processing of the welfare claims of registered construction worker.

- 4. The representative raised the issue of verification of work experience of 90 days of construction worker. It was clarified by the Additional Labour Commissioner that the verification can be done by the site Engineer or contractor for the work period for which they have been engaged at the site and the rest of work period, if any is to be verified by the previous empl yer or contractor where earlier they might have worked.
- 5. The Additional Labour Commissioner informed the members that in order to notify the Assistant Engineer as registering officer for registration of construction worker and Executive Engineer as recommending officer for processing of claims of registered construction worker, the issue shall be put forth as an agenda item before the Delhi Building and Other Construction Worker Welfare Board (DBOCW) for consideration. Thereafter the board shall move a proposal for necessary amendment.
- 6. The meeting ended with vote of thanks to the Chair.
