This is regarding directions of Hon'ble High Court in WP (C) 4572/2007 titled as "Manushi Sangthan Vs Govt. of Delhi &Ors",

The Hon'ble High Court vide its order on 10th August, 2017 directed the Chief Nodal Officer / Pr. Secretary, PWD to co-ordinate with both Delhi Traffic Police as well as North, DMC to take positive steps and appoint Civil Defence Marshal in the NMV lanes with a clear set of instructions as to their duties so that a review of the actual operation of NMV Lanes on the above stretches be presented to the courts on the next date. The Hon'ble High Court vide its order on 23rd October, 2017 subsequently noted that realistic assessment of the number of traffic marshals to be resolved within the next week so that the deployment of traffic marshals is not delayed any further.

On 5th December, 2017 the Court further directed that concrete steps to be taken in Description of the control of the co

As no specific funds are earmarked for the same and as both activities are geared towards combating pollution and amelioration of the environment, the following required for stage-1 of the imitative is forwarded for your kind consideration. In view of Environment Compensation Charge (ECC) funds being available/managed by the Transport Department, it is requested to release funds from ECC account for the following:

- 1. Rs.15 Lacs to Divisional Commissioner/ Director (Civil Defence) towards remuneration for deployment of 20 Civil Defence Volunteers as Traffic Marshals at NMV Lane, S.P. Mukherjee Marg for 06 months on pilot basis.
- 2. Rs.15 Lacs to PWD for improvement and maintenance of NMV Lane, at S.P.
- This is issued with prior approval of the Hon'ble Minister for PWD/ Urban Development.
