

विषय:- Administrative Approval/Expenditure Sanction for the work of "Shifting of Poles/Laying Underground cable at main Burari Road:- 1. Shifting of electrical services at Main Burari Road from authority to Shalimar Palace. 2. Shifting of electrical services from transport authority to Bengali Colony" during 2017-18.

In pursuance to the proposal of Pr. Chief Engineer (Maintenance), PWD (GNCTD) vide UO note No. 23(3)/Pr.CE(M)/PWD/326 dated 17.01.2018, I have been directed to convey the Administrative Approval/ Expenditure Sanction of Engineer-in-Chief, PWD for carrying out the work for "Shifting of Poles/Laying Underground cable at main Burari Road :- 1. Shifting of electrical services at Main Burari Road from authority to Shalimar Palace. 2. Shifting of electrical services from transport authority to Bengali Colony for an estimated cost of Rs. 4,06,06,024 (Rs. Four Crore Six Lakh Six Thousand Twenty Four only) subjected to the following conditions :-


1. The expenditure involved is desirable to the Major Head of Account-5054- 04-337- 95 00 53- Strengthening/Resurfacing/Microsurfacing of PWD roads (ARTERIAL) from within the sanctioned budget allotment for the current financial year 2017-18 subject to availability of funds. However, before incurring any expenditure, Engineer-in-Charge must ensure that all requisite codal formalities as per GFR-2005, CPWD work manual, Instruction of Finance Department, GNCTD, GOI and CVC guidelines have been observed.
2. A/A & E/S has been accorded purely based on the estimated calculations submitted by the Pr.CE(M), PWD (GNCTD). However, the detailed requirement such as quantity, rates and its technical specification, feasibility, necessity etc. for each project shall be worked out by the Competent Authority at the stage of preparing detailed estimate/ technical sanction
3. It may be ensured before awarding the work that if any drain work comes under the jurisdiction of PWD, design and execution of the work should be adequate and techno economically optimum and it shall be ensured that water logging does not taken place and the objectives of the work are fulfilled.
4. The tender shall be invited as per the approved cost based on DSR-2014 minus 12%.
5. Works shall be completed within the given time frame and within the sanctioned cost.

6. Financing the works shall be managed by the Engineer-in-Charge as per the provisions made in its budget for respective works.
7. The Engineer-in-Charge and /or construction agency must not change the scope of work in any manner as indicated in the Preliminary Estimate without approval of the Competent Authority.
8. Engineer-in-Charge/ construction agency may identify the probable impediments in the execution of projects well in advance and may project contingent measures/ plans as identified to deal with them, so as to ensure completion of the projects as per approved time schedule.
9. Work completion certificate and copy of the 3rd party Quality Control Certificate (if applicable) may be furnished to Chief Engineer which in turn will apprise the Pr.CE(M) & Engineer-in-Chief, PWD (GNCTD) of the completion of work as per prescribed standards and schedule.
10. The Construction Agency shall submit the final bill to Engineer-in-Chief reporting utilization of funds, completion of project and settlement of advance/ deposit money on the completion of the work/ project.
11. It will be ensured that all the payments to contractors are made through electronic fund transfer only.
12. The concerned Engineer/ Contractor shall ensure that the quality of the road shall be as per standard prescribed.
13. This Sanction issue with the approval of E-in-C, PWD (GNCTD) vide U.O. No. 23(3)/Pr.CE(M)/PWD/326 dated 17.01.2018 (NP-1 to 9).
