Subject: - Construction of two cluster bus depots including boundary wall at Sector-37, Rohini, Delhi

Sir,

1. I am to refer to letters bearing No.23(104)/PM/F.1/PWD/2018/402 & No.23(104)/PM/F.1/PWD/2018/403 of March 19, 2018 of Project Manager (F-1), PWD on the aforementioned subject and to say that the EFC Committee considered the EFC Memorandums submitted by PWD along with the aforesaid letters in its meeting held on May 15, 2018 and accorded approvals for construction of two cluster bus depots at Sector-37, Rohini, Delhi by PWD at an estimated cost of Rs.43.76 crore (Rs.21.05 crore + Rs.22.71 crore), subject to the following conditions:-


- (i) Project shall be completed as per approved scope of work within 9 months at the sanctioned cost. No cost escalation will be considered in future.
- (ii) NIT shall be invited as per the approved scope of work and sanctioned cost.
- (iii) Compliance of pre-sanction/post-sanction guidelines/requirement circulated as Annexure to Government Order No.PA/DSF/Misc./2012-13/Exp.4/538-45 dated 17.05.2012 during planning and execution period.

2. A copy of the minutes of the said EFC meeting held on 15.05.2018 is enclosed herewith for your ready reference and compliance.

3. In view of the above, I am to request you to kindly direct the concerned Engineers in PWD to do the needful immediately. Shortly, this department will make part payment, in the current financial year, to PWD for the said project.
