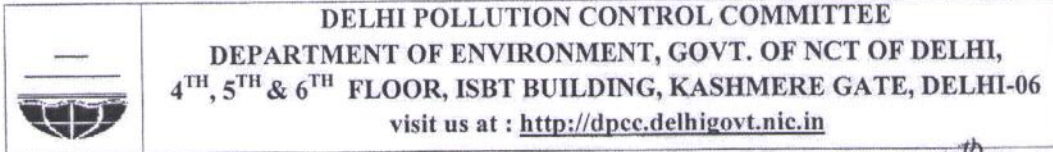

**ORDER**

In view of severe air pollution situation caused by dust in Delhi, directions issued by Hon'ble Lt. Governor in the high level meeting on 14.06.2018 with all the stakeholder Departments/Agencies, directions of EPCA, recommendations of task force constituted under CPCB and provisions of Graded Response Plan for Delhi & NCR, all concerned Departments/Agencies are directed to ensure compliance of following decisions in additions to the provisions of Graded Response Plan already enforced;

1. Municipal Corporations, DPCC and all construction agencies are directed to enforce directions issued by DPCC vide order **F. No. DPCC/PA to MS/2018/89-109 dated 14.06.2018** to stop all Civil Engineering construction in Delhi
2. Municipal Corporations and PWD are directed to intensify mechanical road sweepings and sprinkling.
3. Municipal Corporations, DDA and SDMs are directed to strictly enforce prohibition on open burning of garbage, plastics and leaves etc..
4. Municipal Corporations, DPCC and PWD are directed to impose fine/penalties on all road construction agencies/contractors, where there are inadequate dust control measures.

All Departments/Agencies are directed to issue necessary notifications/orders for implementation of above directions.

**Sub: Direction under section 31 (A) of Air (Pollution and Control of Pollution) Act 1981 read with Rule 20A(6) of the Air (Pollution and Control of Pollution) (Union Territories) Rules, Act 1983 to stop all Civil Engineering Construction and Demolition activities in Delhi from 15-06-2018 to 17-06-2018.**

Whereas, Central Pollution Control Board is the State Board for all the Union Territories to exercise powers and performs functions under the Air (Prevention & Control of Pollution) Act, 1981.

And whereas, Central Pollution Control Board has delegated all its powers and functions under Air (Prevention and Control of Pollution) Act, 1981 in respect of NCT of Delhi to Delhi Pollution Control Committee vide Notification No. S.O. 198(E) dated 15.03.1991.

And whereas, whole of union territory of Delhi has been declared as air pollution control area vide Notification No. GSR 106(E) dated 20.02.1987 under sub-section (1) of section 19 of the said Air Act, 1981.

And whereas, as per section 17 (1) (a) of Air Act 1981, Delhi Pollution Control Committee (DPCC) is to plan a comprehensive program for the prevention, control and abatement of air pollution and to secure execution thereof.

And whereas, Delhi is facing severe ambient air pollution levels and level of pollutants like particulate (PM<sub>2.5</sub>, PM<sub>10</sub>) has gone up manifold. Dust has been identified as major sources of air pollution.

And whereas, Hon'ble National Green Tribunal in various orders has directed to initiate steps to curb the dust pollution.

And whereas, in pursuant to the order dated 02.12.2016 of Hon'ble Supreme Court of India in the matter of M.C.Mehta Vs Union of India & others regarding air quality, Graded Response Action Plan (GRAP) has been notified by the Ministry of Environment, Forests & Climate

Change, Govt. of India on 12.01.2017 for implementation through Environment Pollution (Prevention and Control) Authority (EPCA).

Keeping in view of curbing severe air pollution in Delhi especially in respect of high PM<sub>10</sub> and PM<sub>2.5</sub> levels and in compliance of directions under GRAP, and orders of Hon'ble NGT w.r.t. Air Pollution and in exercise of the powers conferred under section 31(A) of the Air (Prevention & Control of Pollution) Act, 1981 read with Rule 20A (6) of the Air Rules, 1983, **All Civil Engineering construction activities are directed to stop in Delhi till 17.06.2018 and Municipal Corporations, DPCC and all construction agencies are directed to enforce it.**

All the agencies, to daily submit Action Taken Report (ATR) to "DPCC" on Email id [msdpcc@nic.in](mailto:msdpcc@nic.in).

In case of non-compliance, action as per the provisions contained in Section 37 of the Air Act, 1981 shall be initiated against all defaulters.
