Minutes of Meeting

Minutes of meeting of FOB/Subway Committee was held on 06.06.2018 at 11.00AM under the Chairmanship of Pr. Secretary, PWD at 5th Level, B-Wing, Delhi Sectt. to discuss on various proposals of construction of FOBs/Subways/Underpasses as per detail given below:-

The list of the participants is enclosed as Annexure 'A'.

The gist of discussions/decisions taken is as follows:-

1 FOB near SDMC office and Chhattarpur Mandir, New Delhi :

Sh. Narender Mahajan, Executive Engineer, SR Div-1 PWD informed that the Subway Sub Committee inspected the site on 25-05-2017 and observed that space for one side landing steps/ramps is not available. Considering the site constraints, the FOB Committee rejected the proposal of construction of FOB at the proposed site.

2 FOB near MCD dispensary (Govt. School) :

Sh. Narender Mahajan, Executive Engineer, SR Div-1 PWD informed that the Subway Sub Committee inspected the site on 25-05-2017 and observed that there is a crossing less than 200 metre away from the proposed FOB, so this crossing may be channelized/signalized. Keeping in view the observations of Subway Sub Committee, the FOB Committee did not recommend the construction of FOB at the proposed site.

3 FOB at Harswaroop colony Bus Stop, New Delhi :

Sh. Narender Mahajan, Executive Engineer, SR Div-1 PWD informed that the Subway Sub Committee inspected the proposed site on 25-05-2017 and felt the need for construction of an FOB at the proposed site keeping in view of heavy pedestrian flow and traffic volume count. He informed that as per survey report 1083 persons cross the road during the day and 17714 vehicles passes the stretch during 6.00 PM to 7.00 PM. The proposed FOB shall benefit local people, residents, school going children and other pedestrian for crossing the road safely. Keeping in view the above facts, the FOB Committee unanimously approved the construction of an FOB at Harswaroop Colony Bus Stop on S.S.N. Marg.

4 Foot Over Bridge between Sector-6, Mohan Singh Market at Tamil Sangam Marg :

Sh. S.K.Sinha, Executive Engineer, SWR Div-1 PWD informed that the Subway Sub Committee inspected the site on 10.5.2018 and recommended for construction of FOB at the proposed site. He informed that a foot fall survey was conducted at the proposed site and as per survey report 2497 pedestrians crossed the road during the day. Further traffic density for 12 hours period remained 43861 vehicles at the proposed location. Keeping in view these facts, the FOB Committee approved the proposal for construction of an FOB at the proposed site provided median opening to be plugged and fence to prevent pedestrian crossing at random.

5 Foot Over Bridge at RTR Marg near Petrol Pump :

Sh. S.K.Sinha, Executive Engineer, SWR Div-1 PWD informed that the Subway Sub Committee inspected the site on 10.5.2018 recommended for construction of FOB at the

proposed site. He further informed that a foot fall survey was conducted and as per survey report 1894 pedestrians cross the road during the day. Traffic density for 12 hours period is 84407 vehicles. The settlement around the proposed site is predominantly residential. Pedestrian faces the problems to find the safe gap to cross the road. In view of the above, FOB Committee approved the proposal for construction of an FOB at the proposed site.

6 **FOB at Baba Gang Nath Mandir on Nelson Mandela Marg, New Delhi :**

Sh. S.K.Sinha, Executive Engineer, SWR Div-1 PWD informed that the Subway Sub Committee inspected the site on 10.5.2018 and proposed for construction of FOB at the proposed site. He further informed there is heavy pedestrian flow and traffic volume count the proposed location. As per traffic survey conducted, 2497 pedestrians cross the road during the day and there is 43861 vehicles passes the proposed location during 12 hours period. FOB Committee approved the proposal for construction of an FOB at the proposed site.

7 **FOB at Sultanpuri 908 Main Bus Stand :**

Executive Engineer, North West (Road)-2 informed as per Sub-Committee report FOB at this location is not feasible due to congestion of space and traffic movement is also slow at this location. The Sub Committee recommended for provision of some pallet with pelican light/Zebra crossing & signage at the proposed location. In view of above, the FOB Committee rejected for construction of FOB at the proposed location and directed to take measures as suggested above.

8 **Construction of FOB at Sarai Kale Khan :**

Chief Engineer (South)M informed that a request from Hon'ble MLA Sh. Praveen Kumar was received for construction of FOB at the proposed location. Accordingly, an inspection of Subway Sub-Committee was held on 23.04.18 which recommended for construction of FOB at ISBT Sarai Kalen Khan. A feasibility study was also conducted by M/s SNT Infratech Pvt. Ltd. giving report on pedestrian cyclist count and vehicular traffic flow either sides of the road. As per report in general 495 persons cross the road per hour in peak time. Near the proposed location, no grade separated pedestrian facility available to cross the road safely. Keeping in view of above, the FOB Committee approved the proposal for construction of an FOB at the proposed site .

9 **Construction of FOB at Shakurpur Village (on Inner Ring Road – Mahatama Gandhi Marg) connecting Dada Devta Mandir, Lawrence Road Industrial Area to Shakurpur Village :**

Proposal was tabled by Sh. A.K. Pandit CE(North) during the meeting. He informed a huge traffic comes from Punjabi Bagh side at very high speed after decending the flyover and ROB near Dada Dev Temple on Ring Road and from Azad Pur side the traffic merges near temple coming from side loop of Lawerance Road and by decending of the Britania Flyover. A bus stand exists near Dada Dev Temple and Lawerance Road industrial area is also very close to it. On the other side of Dada Dev Temple Shakur Pur village exists in which huge population lives and three schools are also in existence near the proposed location. Keeping in view heavy pedestrian and traffic flow, the Subway Sub Committee has recommended construction of FOB at the proposed location. FOB Committee also unanimously approved the proposal.


10 **Foot Over Bridge at Road NO. 36 near New Era Public School Maya Puri:-**

Executive Engineer, SWR-1, PWD informed that this case was earlier taken up in the 52nd FOB/Subway Committee meeting on 9.10.2014. The need for this FOB feit in view of five schools on one side of the road. The officers from UTTIPEC stated that there is likelihood

of pedestrian traffic only at the time of arrival & departure of school students. They suggested that provision for at grade pedestrian traffic signal may be made for few months and thereafter it can be reviewed by the Committee. Traffic Police representatives also agreed with the proposal of the UTTIPEC. The committee decided to provide pedestrian traffic signals for crossing of the pedestrian trial basis for 3 months and place the report before the committee.

Now after examination of the traffic and needs of pedestrians, DCP(Traffic) Western Range vide letter No.161 dated 16.01.2018 has expressed that keeping in view the safety of general public and school going children, as per traffic point view there is no problem in execution of Foot over Bridge in the regard. Accordingly, Committee approved construction of Foot Over Bridge at this location.
