
This is in continuation of letter No. F 14(01)2017/T-I/Pr.AO/1607-1709 dated 29.06.2017 and its subsequent reminders dated 22.11.2017 and 07.05.2018 of the Controller of Accounts GNCT of Delhi in which it was requested to issue necessary instructions to the Heads of Offices under your control to submit the cases of the revision of pensions/family pension in respect of Pre 2016 pensioners/family pensioners to Pay & Accounts Office concerned after fixation of notional pay of the pensioners/family pensioners in the Pay Matrix recommended by the 7th CPC in the Level corresponding to the pay in the Pay Scale/Pay Band at which they retired/died.

It has been noticed that in spite of the above said instructions, cases of the revision of pensions/family pensions are not being submitted by the Heads of Offices to the Pay & Accounts Offices and as pointed out by the Chief Controller of Accounts, Central Pensions of Accounting Office, Ministry of Finance, in 54185 pension cases in respect of GNCT of Delhi pension is still to be revised. Further to review the huge pending cases of revision of pensions/family pensions a meeting has been fixed under the Chairmanship of the Additional Secretary (Expenditure), Govt. of India, Ministry of Finance on 21.06.2018.

It is therefore requested that Heads of the Offices under your control may be advised to review all outstanding cases of revision of pension/family pension and arrange their submission to the Pay & Accounts Office concerned in a time bound manner.

It is also requested that a Nodal Officer may be appointed in your department to review the progress of revision of pension/family pension cases and to send a Monthly Report on 5th of every month in enclosed Performa to the Dy. Controller of Accounts (Tech) Principal Accounts Office, GNCT of Delhi, B Block Vikas Bhawan, New Delhi on his e-Mail address (dcoatechpao.delhi.gov.in)


