Sub: **Information pertaining to Insurance of Govt. vehicles/Staff Cars in pursuance of meeting held on 07.03.2018 and 19.06.2018**

Sir/Madam,

A meeting was held in GAD on 07.03.2018 and 19.06.2018 on various issues raised by the Delhi Sarkar Vahan Chalak Kalyan Samiti (DSVCKS), wherein the issue of insurance of Govt. vehicles was also discussed (copy of minutes of the meeting held on 19.06.2018 are enclosed for ready reference).


In the meeting, the representatives of DSVCKS had requested that at present, there is no provision for insurance of Govt. vehicles/Staff Cars in GNCTD, due to which many a times drivers were directed by the Court to pay part of the compensation awarded arising out of the accident. It was therefore requested by the DSVCKS that third party insurance of Govt. vehicles should be done by Delhi Government. The officers of Finance Department present in the meeting stated that Finance Department could examine the demand, in case relevant information pertaining to the matter (any claim arising out of accident involving Govt. vehicle which the department or driver has paid in the past) is provided by all the departments to FD and on the basis of last 5-10 years information about comparison between amount of insurance Vs amount paid in accidental claims, FD may be able to give its view/recommendation.

A number of Departments have already provided information in the matter to GAD. However, the information from your department is still awaited and as the matter is getting delayed. It is requested that the information may be provided in the **Performa** enclosed urgently to GAD for onward submission to Finance Department.

This may be treated as most urgent.
