**ORDER**

Subsequent to office order No.Min4/PWD/2017/2782-93 dated 18/09/2018, dissolving the "Consultant Appointment Committee" the following is ordered, in line with the CPWD manual.

All Chief Engineers/Chief Project Managers will exercise powers to appoint private architects/consultants subject to the following conditions.

- 1) The powers for appointment of Private Architect/Consultant are delegated to Chief Engineer/Chief Project Manager of PWD subject to in principle approval of Pr. Chief Engineer, PWD. Chief Engineer/Chief Project Manager will exercise such powers for the works which fall within their competence to accept final bids as per delegation of financial powers. In case, amount of the bids for consultancy work exceeds the delegated financial powers of Chief Engineer/Chief Project Manager, approval of the Competent Authority i.e. Pr. Chief Engineer/ Engineer-in-Chief as the case may be, will be obtained for appointment of Private Architect/Consultant.
- 2) These powers shall not be sub-delegated to any other authority by the Chief Engineer/ Chief Project Manager.
- 3) The Chief Engineer/Chief Project Manager shall be Competent Authority to assign extra work to consultant for same project and fee to be paid for the extra work so assigned.
- 4) The Chief Engineer/Chief Project Manager shall follow the other related provisions of CPWD Works Manual in this regard.

This issues with the approval of Hon'ble Minister, PWD, GNCTD.


