Subject: **Preliminary estimate for construction of bridge on Supplementary Drain on NH-10, Nangloi, Delhi to cover complete width of 60m with road improvement in 100 meter length on either side of bridge including making of drainage scheme, footpath etc. complete (after dismantling the existing bridge).**

Sir,

The existing old RCC Bridge across Supplementary Drain at RD 22471m of Delhi Rohtak Road section of NH-10 is to be remodeled by PWD as per the revised design, discharge of the drain and traffic intensity. The drain on the U/S & D/S of this bridge has been widened & deepened, as such this bridge is obstructing the entire flow. There is appreciable difference of levels upto 2.5m hence massive obstruction is caused in the flow of the Supplementary Drain and the drain is not functional upto its full capacity due to obstruction in flow there is constant heading of water in upstream area like Kakraula, Nihal Vihar, Ranhola. Further flooding is also observed in these areas during rainy season.

It is relevant to mention that project manager F-1, Public Works Deptt., Govt. of Delhi has submitted a preliminary estimate amounting to Rs. 42.21 Crore along with analysis of rates, details of measurement, history sheet and drawing has submitted to your good office vide letter F. No. 23(106)/PM/F-1/PWD/2018/2010 dated 08.02.2018 for accord of A/A & E/S.

The above matter has also been discussed in the committee constituted by Hon'ble High Court chaired by Mr. P.K. Tripathi (IAS Retd.) in the matter of CM No. 30022/2018 in W.P. (C) 7594/2018 on dated 05.10.2018.

In view of the above facts, it is requested that you may kindly take urgent necessary action regarding issuance of A/A & E/S and direct Delhi PWD Officials to take up the work at the earliest.
