- ITEM 1: Provision of 10% discount in fares on usage of DMRC metro card in DTC and Cluster buses.

Decision: No. 2651

The Council of Ministers considered the note of Secretary (Transport) and approved the proposal contained in para 7 of the Cabinet Note.

#### TABLED ITEMS

ITEM 2:

Shri Gopal Rai, Hon'ble Minister for Labour moved the following proposal with the permission of the Hon'ble Chief Minister for consideration of the

"Minimum wages means the bare minimum wages payable under the law. The Government of NCT of Delhi determined fair living wages payable to workers who are at the bottom of the ladder and notified it as Minimum Wages. Hon'ble High Court of Delhi vide its order dated August 4, 2018 struck down the notification for some technical reasons. Payments to all those, who were getting paid at minimum wage rates, got reduced from 4th August as a result of the order of the Hon'ble High Court of Delhi However, that doesn't bar the people oriented present Government to pay the fair living wages to its contract workers employed directly or through

Cabinet decides that payment to all those, who have been directly employed on contract basis by GNCTD at minimum wage rates or who have been employed by contractors in various works of GNCTD at minimum wage rates, shall continue to receive payments at earlier rates prevailing before 4th August.

All orders and notifications, passed by GNCTD, withdrawing earlier rates shall stand amended to that extent.

This decision shall have the following effect -

1. If reduced payments were made as a result of the orders of Hon'ble High Court of Delhi or if any deductions were made, such personnel shall be paid balance amounts equal to the amount of reduction or deduction for the entire intervening period on or before 31/10/2018 to enable them to celebrate Diwali in a meaningful way.

2. Henceforth, payments shall be made on the basis of earlier rates.

GNCTD shall include all Departments, PSUs, Boards, Academies and Autonomous Bodies under GNCTD.

Chief Secretary shall personally ensure that all the reductions and deductions made for the intervening period from 4th August till 31 10.18 is credited to the accounts of the personnel before 31st Oct so that they can celebrate Diwali festival properly.

The Delhi Government has preferred an urgent appeal to Hon'ble Supreme Court and is working on all fronts to ensure payment of fair living wages even to private sector unskilled employees."
