Door Shri Vijay Kumar Dev,

In a short span of less than two years, GeM has established itself as an open, transparent and efficient online procurement platform, offering huge savings to the government. Central and State government departments / organizations have done over 10 lakh procurements worth over Rs.15000 crore through GeM. Such an achievement would not have been possible without the support and encouragement of States, including State teams led by you.

I am writing to draw your kind attention to the tenders floated by State Transport agencies for procurement of buses / hiring or leasing services for buses, notwithstanding the fact that automobiles are available on GeM at highly discounted rates ranging from 12% to 20% over market rates, leading to huge saving to state exchequer. This discount is not available when vehicles are procured outside GeM either through bid or at special govt, prices. We have all the major automobile companies directly listing all models of vehicles including buses. We have recently enabled bus hiring / leasing services also. This I am sure would bring in significant value by way of procurement as a service and also lead to significant savings.

May I therefore request you to issue necessary instructions to the concerned officers specifically Secretary Transport and MD of State Road Transport Authority to procure their requirement of vehicles only from GeM.


