3. The progress for execution of work will be reviewed and monitored by a constituted committee by DTTE on the basis of monthly progress report. The Principal, G. B. Pant Engineering College and Principal, G. B. Pant Institute of Technology may be consulted for any academic norms.
4. The project shall be completed as per approved scope of work within scheduled period at the sanctioned cost. No cost escalation will be considered in future & completion certificate must be furnished to the Joint Director (Planning), Department of Training & Technical Education, Delhi.
5. Phase-I and II shall be executed simultaneously.
6. Compliance of pre-sanction/ post sanction guidelines/ requirement circulated as Annexure to Government order No. PA/ DSF/ Misc/ 2012-13/ Exp-4/ 538-45 dated 17-05-2012 during planning and execution period.
7. That total expenditure will not exceed the budget allocation under the specific sub-head during the financial year.
