Whereas the Delhi Commission for Safai Karamcharis has been constituted under section 3 of the Delhi Commission for Safai Karamcharis Act, 2006 (Delhi Act 7 of 2006) for the purpose of safeguarding the rights and interests of Safai Karamcharis in the National Capital Territory of Delhi.

The commission has taken the cognizance of Social Media news about the incident of Manual Sewer Cleaning in Netaji Subhash Palace, Near Pritam Pura TV Tower on 03/04/2019 which is the violation of "The Prohibition of Employment as Manual Scavengers and Their Rehabilitation Act 2013".

In exercise of power vested in section 12/17 of DCSK Act, the commission required the detailed report in this matter in 10 days after investigation and take action against the concerned officers of the area. The report is still awaited. It is once again requested to send the reply in 05 days for perusal of the Commission

failing which action shall be taken as deemed fit under DCSK Act 2006.
