Sir,

I am directed to forward herewith the copy of D.O. letter of the Chief Electoral Officer, Delhi addressed to the Chief Secretary, Delhi vide No. F.CFO/MCC/86/2019/2056, dated 30/04/2019, regarding violation of MCC and other election related issues.

It has been informed that the Office of Chief Electoral Office, Delhi receive complaints from various political parties, candidates, ECI, media and other forums regarding certain MCC violations and other election related issues. In order to ascertain the authenticity of the complaints, reports are being sought by Office of CEO from various departments of GNCTD for taking necessary action. The Office of CEO has regretted that inspite of the sensitivity of the issue and the directions issued in this regard, certain departments either do not respond to the complaints, or give delayed or incomplete response in answering/clarifying on the complaints/matters forwarded to them. A few examples have also been quoted in the D.O. letter wherein, some departments have not responded to the complaints forwarded by the Office of CEO.

It is therefore requested that in view the fact that time is of essence in handling election related issues, it is requested that matters referred by the Office of Chief Electoral Office, Delhi for comments/AIR, be responded immediately.

This is to bring to your kind notice that the Office of the CEO, Delhi daily receives a number of complaints from various political parties, candidates, ECI, media and other forums regarding certain MCC violations and other election related issues. In order to ascertain the authenticity of the complaints, at times, reports are being sought from various departments of GNCTD so that necessary action can be taken and the complainants can also be duly informed. You will appreciate that time is of essence in handling MCC violation complaints. Any delay in submission of reports by the Pr. Secretaries/Secretaries/HODs of the departments, not only delays the corrective action against such MCC violations but also adversely affects the process of free, fair and transparent elections.

It is, however, regretted to state that inspite of the sensitivity of the issue and the directions issued from the Office of the CEO as well as your office, this office is feeling constrained due to either no response, delayed response or incomplete response of certain departments in answering/clarifying on the complaints/matters referred to them.

To quote a few instances like (a) Seeking report from Pr. Secretary (Health) on complaint of BJP regarding display of photographs of political leaders in Government buildings like government hospitals and mohalla clinics, etc. The original letter dated 13/4/2019 and reminder dated 28/4/2019 has been sent to Pr. Secretary (Health) [copy enclosed]. However, no reply is received yet. (b) Complaint of BJP regarding use of slogan "Aapki Sarkaar Dilli Sarkar" written on CATS Ambulances. The original letter dated 19/4/2019 and reminder dated 29/4/2019 sent to Pr. Secretary (Health) [copy enclosed]. However, no response is received yet. (c) Complaint from one advocate Sh. Aniruddh Shukla regarding holding of Job Fair by Education Department, GNCTD in the guise of political campaigning for AAP. Original letter dated 25/4/2019 sent to Secretary (Education) [copy enclosed] but no reply is received yet. (d) Complaint of BJP against Sh. Nagender Sharma, Media Advisor to CM, Delhi regarding tweeting on political issues inspite being a government servant. Letter dated 18/4/2019 and reminder dated 24/4/2019, sent to Secretary (Services) [copy enclosed]. However, no reply is received yet.

I, therefore, request you to issue strict instructions to all the Pr. Secretaries/Secretaries/HODs that matters referred by CEO Office for comments/ATR, etc. be responded immediately as time is of essence in handling the election related issues. I believe that the matter will have to be brought to the notice of ECI if the current state of affairs continues.

This office is in receipt of a complaint dated 9.04.2019 from Sh. Rajesh Bhatia, Gen. Secretary, BJP, regarding display of photographs of Sh. Arvind Kejriwal and Sh. Satyendra Jain in Government Hospitals and Mohalla Clinics in Delhi (copy enclosed). In this connection your attention is invited to point 9.3 of Model Code of Conduct which states that, "The Election Commission has also instructed that during Model Code period, photographs of Prime Minister, Chief Ministers, ministers and other political functionaries many of whom are still active in public life and may be contesting elections should not be displayed in government buildings/premises as that would have the effect of disturbing the level playing field vis-à-vis the political functionaries of other parties and candidates."

In view of the above, I am directed to convey that all Medical Superintendents of the Hospitals and Incharges of the Mohalla Clinics may be directed to ensure strict compliance of the aforesaid clause i.e. 9.3 of MCC. Further, it should also be ensured that no display of photographs of any leader of Political Party on Hospitals or Mohalla Clinics etc. are there in violation of the Model Code of Conduct. Action taken report be submitted within 3 days.
