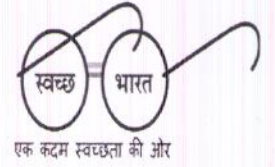

ORDER

Whereas, the Hon'ble Supreme Court of India while hearing Writ Petition(s) No(s). 13029/1985 in the matter of M.C. Mehta Vs. Union of India & Ors. has passed orders dated 04.11.2019 and 06.11.2019 directing the Chief Secretary, GNCTD to ensure implementation of a number of measures to control various factors which are contributing to the pollution in Delhi such as construction and demolition, open dumping of waste, garbage, unpaved roads/pits, road dust, garbage burning and traffic congestion. In addition, the Hon'ble Court has further directed the Chief Secretary to take care of the hotspots and implement immediate measures for addressing the problem of higher level of air pollution in the identified hotspots.

- Whereas, the Hon'ble Supreme Court has further requested the Monitoring Committee also to look into these aspects and has authorized the Committee to monitor the activities as to whether orders of the Hon'ble Supreme Court are appropriately carried out.
- In pursuance to the above orders, the Monitoring Committee held a meeting on 07.11.2019 in which the HODs/Nodal Officers of the various implementing agencies as Municipal Corporations, DDA, DJB, PWD, Delhi Police, DSIIDC, Department of Industries, NHAI and DPCC were present. After detailed deliberations, the certain directions have been passed in consultation with the Monitoring Committee for time bound implementation thereof vide order no. DPCC/Air Lab/ 2019/GRAP/Dir/ 456-478 dated 07.11.2019.
- In pursuance to the above orders, Principal Secretary, PWD held a meeting on 08.11.2019 in which E-in-C, PWD, Pr. CE(M & F) PWD, CE(South), PWD, CE(North), PWD and all concerned SEs were present. During the meeting following directions have been given for time bound implementation.

5. Other Compliances:

- Requisite machinery, equipments, vehicles and other resources shall be mobilized as and when required. Respective SEs will be responsible for this action.
- The matter of illegal dumping of C&D waste, garbage and plastic waste shall be reported by concerned EE of that area to Joint CP/DCP of respective Police District of concerned range.
- Systemic efficiency to be so improved by concerned AEs so that complaints noted by the inspecting teams and by the public on Sameer App are obviated.
- Concerned SEs of Hotspots shall prepare a roster of JEs for night patrolling on various road stretches falling in particular hotspots to ensure that no C&D waste/garbage/MSW is dumped on PWD road/plots etc. The concerned SE shall write to Div. Commissioner for deployment of requisite no. of Marshals to assist the team for night patrolling. The night patrolling team shall identify the illegal activities and report to the EEs on daily basis with photographic/video graphic evidences about violation by concerned agency/individual. EEs will write to the concerned Municipal Corporation/DPCC/Police for taking penal action under the law and will lodge FIR also.
- The concerned EEs shall write to SHO of the areas for providing Police protection to the patrolling team.
- Environmental compensation be levied by authorized AE against the violators.
- Affidavit on the above specific points and in compliance of directions of Hon'ble Supreme Court of India and as per direction given by the Principal Secretary (PWD) in meeting held on 08.11.2019 is to be submitted by each SE by 11.11.2019. The action taken date wise should be detailed in the affidavit to be provided by each SE.

- Detailed reports along with photograph/video record are to be uploaded everyday by concerned SEs in the proformas available on specifically designated corner for this purpose on PWD Website.
- The aforesaid actions shall be sustained even after 11.11.2019, so that True implementation of the orders of the Hon'ble Court is ensured.
- In case of any non compliance, the concerned officers will be held personally responsible and appropriate action will be taken for such negligence.
- Action should start with immediate effect and report be uploaded including Saturday/Sunday and Holidays.
