Consequent upon implementation of GFR 2017 and as per the provisions in Rule 149, all the procurement of Goods or Services by the departments will mandatorily be through GeM, which is an online facility/platform for hassle-free procurement of common use Goods and Services in a time bound/fair/transparent/reasonable manner.

The Hon'ble Minister of Commerce and Industry in his letter dated 19th June, 2019 has urged to increase the UT's footprint on GeM and thereby leverage the technology and economics of scale to achieve further savings, while procuring in an efficient and transparent manner. Also, attention is invited to OM dated 24th September, 2019 of DOPT informing that the reflection of the work done through GeM by the Officer Reported upon shall be made in the APAR of Group 'A', Group 'B' and Group 'C' officers belonging to Central Civil Services (other than All India Services).

GNCTD has been awarded 'GeM Top Buyer 2018' Award in the Super Buyer Award Category by the Ministry of Commerce and Industry, Govt. of India. Further, as on October 2019 (FY 2019-2020), GNCTD ranks First in volume and Second in value in respect to GeM transactions.

It is pertinent to mention that GNCTD is using Integrated Financial Management System (IFMS) and accordingly all payments are being released by PAOs through GeP Gateway. However, even after release of payment by the PAOs in respect of the orders procured by Departments, the transactions are shown as incomplete till the buyer department updates the payment details manually in the GeM portal.

As per the information received from GeM authorities, payment on the part of GNCTD to the tune of Rs.147.42 crore is due to the vendors for more than 60 days. Details of the same is annexed. However, there is a possibility that the same may include those payments in respect of which payment has already been released by PAOs and are pending for manual payment updation by the buyer department in the GeM portal.

In view of above, I request you to kindly look into the same and expedite release of outstanding payment, if any due for more than 60 days and also ensure that no payment is delayed for more than 15 days in future. The updation of missing payment entry in GeM portal may also be ensured without fail as this is being , taken by Govt. of India regularly.

Madam /Sir,

This Department, vide letter dated 03/09/2019, had requested Ministry of Home Affairs, Govt. of India for seeking clarification from DoPT, Govt. of India regarding determination of the period of ACRs/APARs that is to be taken into account for considering grant of ACP/MACP benefits.

The Ministry of Home Affairs, vide their letter no. F.No. 14012/05/2019-Delhi-I Dated 8/10/2019, has forwarded the advice of DoPT, Govt. of India, in the matter, which is as under:

'The matter has been examined in this Department. In this regard, it is mentioned that DoPT vide its O.M. No.22011/4/2013-Estt.(D) Dated 08th May, 2017 has already issued instructions relating to procedure to be observed by the Departmental Promotion Committees(DPCs) inter alia relevant year up to which APARs are to be considered.

Since, benefit of financial upgradation under ACP/MACP Scheme is given to a person in lieu of promotion who is stagnating in the same grade for a certain time period, provided he fulfils other eligibility conditions. In so far as the determination of ACRs/APARs to be taken into account for considering grant of ACP/MACP benefits, there is no variation or relaxation in the provision under ACP/MACP Scheme. Therefore, the instructions including determination of period of ACRs/APARs to be taken into account for promotion are also applicable for the cases considering grant of ACP/MACP benefits'.

This is for information and compliance.

- 2. This is regarding a reference received from MHA seeking clarification of DoP&T regarding determination of period of ACRs/APARs to be taken into account for considering grant of ACP/MACP benefits.
- 3. The administrative Ministry has stated that as per rule, provision laid down in para 17 of Annex.-I of MACP Scheme 2009 vide O.M. dated 09.05.2009, the financial upgradation would be non-functional basis subject to fitness, in the hierarchy of grade pay within the PB-I. Thereafter for upgradation under the MACPS the benchmark of 'good' would be applicable till the grade pay of Rs. 6600/- in PB-3. The benchmark will be 'Very Good' for financial upgradation to the grade pay of Rs. 7600 and above. However, in the guidelines of MACP, it has not been clarified as to the period for which APARs are to be considered by the screening committee for ACP/MACP benefits.
- 4. The matter has been examined in this Department. In this regard, it is mentioned that DoPT vide its O.M. No.22011/4/2013-Estt.(D) dated 8th May, 2017 has already issued instructions relating to procedure to be observed by the Departmental Promotion Committees (DPCs) inter alia relevant year up to which APARs are to be considered.
- 5. Since, benefit of financial upgradation under ACP/MACP Scheme is given to a person in lieu of promotion who is stagnating in the same grade for a certain time period, provided he fulfils other eligibility conditions. In so far as the determination of period of ACRs/APARs to be taken into account for considering grant of ACP/MACP benefits, there is no variation or relaxation in the provisions under ACP/MACP Scheme. Therefore, the instructions including determination of period of ACRs/APARs to be taken into account for promotion are also applicable for the cases considering grant of ACP/MACP benefits.
- 6. In view of above, file may be returned to the Administrative Ministry (MHA) to take necessary action, accordingly.

STANDING ORDER

In exercise of the powers vested in the undersigned under rule 15 and Rule 16 of the transaction of Business of the Government of NCT of Delhi Rules 1993(TBR) and in supersession of all previous orders issued on the subject, 1 advertisements by various Departments and Bodies under GNCTD:-

- The Administrative Department/Body will provide the content, based on facts, figures, punch-lines, photo etc., if any, and draft design/ script of the advertisements to be released.
- The Department/Body will also provide the broad purpose and objective for the release of advertisements.
- 3. The content of the advertisements such as facts, figures, etc. shall be certified by the respective HOD in accordance with the Hon'ble Supreme Court Guidelines on Government Advertising. The content and draft design/ audio/ video script shall be approved by the Minister (In-charge) of the Administrative Department or Chairman of the Body.
- The Administrative Department/Body can either use the services of Shabdarth (an advertising agency of Government of NCT of Delhi) for preparing the design of the advertisement/script for audio/video advertisement or can use any other individual/agency as per their choice for this purpose. Administrative Department/Body may take services of agencies empanelled with it or with DIP etc. for this purpose on their own. Services of DTTDC can also be taken for this purpose, if required.
- 5. DIP is entrusted for releasing advertisements at DAVP rates only through DAVP enlisted media. If any advertisement is required to be released at Non-DavP rates then the concerned Department shall take the Finance Department's approval before sending the proposal.
- 6. The Administrative Department/Body shall also provide media preferences, if any, such as Print, Radio, TV, Digital Media, Outdoor Media etc. and language preferences also e.g. Hindi, English, Urdu, Punjabi publications.
- 7. The above advertisement proposals approved by Minister (In-charge)/ Chairman of the concerned Body shall be submitted to Minister (IP).
- 8. The advertisement proposal from the department concerned should reach at least one day before the publication date. However, in the interest of time, in cases of extreme urgency, the approval of the Competent Authority can be sought digitally which shall be reduced to writing as soon as possible. These instructions are also applicable to all forms of advertisement with Print, Electronic, Outdoor, Digital, New Media and all available media solutions on DAVP platform.

- The DIP will finalize the design/script/production with-modifications in the language of the content etc. without affecting the broad meaning of the content, if needed.
- 10. The DIP will finalize the media plan considering the preferences of the Administrative Department, if any, in consultation with Minister (IP).
- 11. The final media plan and design/production to be approved by the Minister (IP).
- 12. After providing content certification, draft design and Supreme Court Guidelines compliance Certificate, the file will not be routed for any purpose to the administrative department. The rest of the work i.e. finalization of design, expenditure sanction, release of advertisement and media plan will be the sole responsibility and jurisdiction of DIP in consultation with Minister (IP).
- 13. The Government has provided budget for all its information and publicity requirements with the Directorate of Information & Publicity. Accordingly, administrative approval and expenditure sanction will be given by the officers of DIP including Secretary and/or Director depending on their financial powers as per Order No. Dy.CM/2019/7873-7877 dated 18.11.2019 or any other order issued from time to time.
- 14. To get the advertisements released through DIP at DAVP rates the proposal of Autonomous Bodies/Boards/Corporations/Commissions/Academies etc. shall be submitted through CEO/Secretary/Administrative Head of such bodies through Minister (In-charge) to Minister (IP). The payment in such cases, however, shall continue to be made by the concerned body.
- 15. This procedure shall be applicable for release of advertisements (print, electronic, outdoor, digital, social media etc.) other than classified advertisements. The classified advertisements shall continue to be released as per prevailing procedures and practices.
