Your kind attention is drawn to first interactive meeting on above mentioned issues convened on 28.11.2019 at 11:30 A.M. at Auditorium, Ground Floor, Delhi Secretariat, I.P.Estate, New Delhi which was presided by Hon'ble Minister of Labour and was attended by representatives of various departments and contractors/outsourced agencies deployed by various departments.

In the said meeting the Hon'ble MoL had expressed his concern regarding less payment/late payment to outsourced employees/workers employed by various Deptts. of Govt. of NCT of Delhi through various contractors/outsourced agencies. A compliance report was also requested. However, many departments/contractors had not got the report on above issues. Accordingly, the 2<sup>nd</sup> interactive meeting was scheduled for 16.12.2019 at 11:30 A.M. at Auditorium, Delhi Secretariat, New Delhi. However, it has been decided to seek status report of compliance from various Deptts. **accordingly, the 2<sup>nd</sup> interactive meeting shall be convened on 20.12.2019 at 11:30 A.M. at Auditorium, Ground Floor, Delhi Secretariat, I.P.Estate, New Delhi which will be presided over by Hon'ble MoL.**

In order to see the status of compliance in respect of disbursement of arrears of minimum wages at revised rates for the month of October, 2019, disbursement of wages at enhanced rates of minimum wages for the month of November, 2019 and disbursement of bonus in respect of outsourced staff/workers employed by various Deptts. Compliance from all the Deptts. regarding above issues is being sought in writing so that a compiled status report from all the Deptts. can be submitted to Hon'ble MoL for his kind perusal and information.
