**Sub: Relieving of Officers/officials deployed for conduct of General Election to Delhi Legislative Assembly Election, 2020.**


Sir/Madam,

I am directed to bring it to your kind notice that a large number of officers/officials from various departments of Govt. of NCT of Delhi have been deployed by Returning Officers/office of CEO and also by Services Department as per the requirement of the office of CEO, Delhi for the smooth conduct of General Election to Delhi Legislative Assembly-2020. Now, vide letter No. 437/6/INST/ECI/FUNCT/MCC/2020 dated 12.02.2020 of Principal Secretary, Election Commission of India, it is informed that since the result in respect of NCT of Delhi has been completed, the Model Code of Conduct in effect since 6<sup>th</sup> January, 2020, has ceased to be in operation in the NCT of Delhi with immediate effect. It is pertinent to mention here that the work of various administrative Departments and offices is being severely affected in the absence of the officers and officials from the departments.

It is, therefore, requested that the officers/officials deployed with Returning Officers/Office of CEO, Delhi, may be directed to report back to duties forthwith in their respective departments so that functioning of departments is not hampered any further. It shall be the responsibility of the Pr. Secretary/Secretary of Department to ensure that all their officers/officials join back the departments. It is further requested that Services Department may also be apprised of the action taken in the regard.
