Instructional order on preparedness for Monsoon

हैनार विवास के पुत्र Since, the monsoon has already set in, the following instructions already issued are

अमुख अभियन्ता । विशेषाक (कॉर्य एवं स्था.) निदेशक (अनुरक्षण)

1. All the tappings constructed for trapping of sewage from storm water drains should be closed to ensure free flow of storm water during monsoon months.

2. All the pumps/ motors of SPSs should be made functional in all respect.

Generator sets be stationed at critical installation.

- 3. Adequate staff should be deployed round the clock for operating the Sewage Pumping Stations. The respective EEs/AEs will also have frequent site visit to ensure the availability of the staff.
- 4. All deep works should be stopped and it should be ensured that trenches should be filled in and malba/surplus earth should be removed on daily basis after completion of work. It should be ensured that trenches are properly barricaded, precaution/ diversion boards are fixed at appropriate locations and lighting arrangements during night hours are in place.
- 5. It shall be ensured that all the storm water drains/street drains are cleared of the malba/ surplus earth during and after execution of DJB works.
- 6. All vulnerable points should be identified and adequate filter water supply should be arranged to avoid water borne diseases.
- 7. In continuation to the above the following vulnerable points shall be regularly monitored by the respective CE (maintenance) in coordination with their counterpart in PWD/MCD as the case may be.
- 8. During the monsoon, rain water along with debris is likely to enter into sewerage system. Accordingly, it will be prudent to keep the recyclers / jetting

- 9. Apart from above, CE (Dr) Project-I, II & III will ensure that all rokas in the rehabilitation / project works are removed and the executing agencies be asked to inspect their site and do necessary arrangement at strategic locations to ensure smooth flow of storm water.
- 10. All CEs are directed to be in regular touch with their counterpart in PWD and Municipalities and Joint efforts should be made to mitigate the water logging problem.
