Minutes of Meeting of Delhi Works Advisory Board held on 09-12-2020 in the Conference Hall , O/O Engineer –in-Chief, PWD, Govt of NCT of Delhi.

A meeting of Delhi Works Advisory Board was convened on 09-12-2020 at 4 PM under the Chairmanship of Engineer-in-Chief, PWD in the Conference Hall, Office of the E-in-C and attended by the Officers as per list attached at Annexure-A in which following agenda items were discussed.

Agenda No.1

Name of the Work: Providing Heating arrangement for 2000 Beds at the existing halls of Radha Swami Satsang Board, Chhattarpur, New Delhi being converted into a temporary 10000 bedded COVID Care Centre, having financial implication of Rs.6,96,33,400/-



1. The Chief Engineer(Health) presented the details of the bid and details of the work, before R.W.A.B. which is summarized below.

i)The proposed work falls under the category of Emergency Works in view of Spread of COVID epidemic, and it was proposed by the Department , to execute the work, through call of quotations as permissible under CPWD manual. However, short notice quotations were called through Delhi govt e-procurement website, after giving 7 days period, for submission of bids. In the instant case, the powers to award of work with call of quotations vests with the Delhi Works Advisory Board, as per financial powers delegated vide CPWD OM No.DG/MAN/376 dated 6-8-2018 , hence the case has been brought before the Board to consider the case for award of work.


ii) The committed date for completion of work according to AA & ES is 15 days for execution, after award of work.

iii) The call of Notice inviting quotations for the whole scope of work is as per AA & ES . A.A. & Exp Sanction for Rs. 7,81,82,252/- was accorded by the Competent authority , as conveyed by the Special Secretary (Health & FW) and Mission Director, DSHM , vide letter No.52/DGHS/PH-IV/Covidd-19/2020/1/5356/2020 dated 30-11-2020 .

iv) The technical sanction amounting to Rs. was accorded by the S.E.(Electrical) Health, PWD vide letter No.03/SE(E)/Health Circle/PWD/2020-21 dated 03-12-2020 for Rs.7,03,29,734/- . Approval for Notice inviting quotations was issued by the Chief Engineer (Health) PWD , in the relevant file, on the estimated cost of Rs.6,96,33,400/-.

v) The NIQ was uploaded in the Delhi Govt website on 1-12-2020 vide tender ID 2020\_PWD\_197101\_1 and the same was opened on 7-12-2020 at 3 PM.


vi) The Chief Engineer (Project) Health has clarified to the Board that the rates quoted by the L-1 tenderer, M/S Hilltop Refrigeration is Rs. 6,10,47,602/- which is 12.33% below the justified market rates and within A.A. & E.S. accorded by the Competent Authority.


2. Status of Financial Bid details, as presented by the Chief Engineer(Health) is as under:


- a) Estimated cost(ECPT) Rs.6,96,33,400/-  
b) Justified cost Rs.7,81,82,252/-  
c) Lowest Bidders Name M/S Hilltop Refrigeration  
d) Tendered amount Rs.6,10,47,602/- which is 12.33% below the Justification of rates and below estimated cost


3. Decision of the Delhi Works Advisory Board.


i) Owing to urgency and circumstances of the case, Delhi Work Advisory Board decided to approve the lowest bid of M/S Hilltop Refrigeration amounting to Rs.6,10,47,602/- which is 12.33% below the justification of rates, with the direction that Chief Engineer(Health) shall issue the award letter and all efforts should be made to execute the work within 15 days after the award of work as per terms of NIQ and as per directions received from Health & Family Welfare Department and in the larger interest of public/COVID patients. At the same time, it should be ensured that the work is executed as per specifications mentioned in the schedule of works, and as per rules and regulations stipulated under GFR/CPWD Manual & other instructions issued by the Govt of NCT of Delhi.


