OFFICE MEMORANDUM

Sub.:- Revised instructions regarding transfer/posting of EEs/AEs/JEs in PWD Delhi.

The Govt. of Delhi vide its order No. F. 10(129)/2002/PWD-I/Vol.IV/238-245 dt. 14.11.2006 has approved the restructuring of PWD Delhi for creating 7 zones in Delhi PWD instead of 4 existing zones. In view of the major restructuring of PWD it has become imperative that guidelines regarding transfer/posting of engineers are revised keeping in view the functional jurisdiction of new zones.

- All the officials working in PWD, Delhi should be <u>deemed to be on</u> <u>deputation to the Government of National Capital Territory of Delhi.</u>
- The normal tenure of posting of engineers from CPWD to PWD Delhi shall be 3 years. The same may be extended upto a maximum of 5 years with the prior approval of the Govt. of Delhi, on annual basis.
- 3. The Govt. of Delhi may relieve any official before the completion of the tenure on administrative grounds or refuse to extend his posting in PWD, Delhi beyond 3 years without assigning any reason, keeping in view exigencies of public service.
- There shall be no fixed tenure of JE/AE/EE within divisions/circles or in specified area i.e. maintenance, projects or planning.
- The instructions issued by D.G. CPWD from time to time and administrative exigencies shall be kept in view while considering transfer/posting of engineers.
- There shall be minimum cooling off period of 2 years before an engineer is considered for posting back to PWD Delhi.
- Govt. of Delhi shall send a quarterly requisition to DG, CPWD for anticipated short fall/excess of various categories of officials so as to have least mismatch in a number of officials available against the post created by the Govt. of Delhi.

For transfer/posting of Engineers above EE, the Engineer-in-Chief, PWD may send a detailed proposal to Pr. Secretary (PWD) for the approval of the Government.

- 9. The Committee shall forward the proposals to PWD Sectt. for approval of Pr. Secretary (PWD). All transfer/posting orders shall be issued under the signatures of Joint Secretary/Addl. Secretary (PWD) after approval of Competent Authority. No modification shall be made to the orders issued by PWD Sectt. and relieving of the officials shall be completed within three working days. In case of non compliance of orders, the concerned administrative in-charge/HOD shall be held responsible. The instructions shall also be applicable for giving additional charge resulting out of vacancy for period exceeding 10 days.
- These instructions shall supercede O.M. No. F.10/23/23/A/2005/PWD-I/1446 52 dt. 10.11.2005.



Dear Stir Raghundhan,

Please refer to your D.O. letter No. 10 (52)/97-PW-I dated 15.3,2005 and subsequent letter dated 24th May, 2005 regarding delegation of more powers and control to Delhi Administration for effective administration on engineers of Central Public Works Department (CPWD) working in Public Works Department (PWD) of Delhi. The proposals have been considered in this Ministry. Following decisions have been taken:-

(i) As regards delegations in the matter of further placement of engineers transferred to Delhi PWD, the Ministry will henceforth place the services of engineers of CPWD up to the level of Chief Engineer with Delhi Government and further postings of individual officers in zones/circles/divisions/sub-divisions can be made by GNCT Delhi. However, while making such internal transfers. Engineer-in-Chief, PWD shall invariably be consulted formally and in writing. It is to be further pointed out that guidelines issued by CPWD from time to time for making postings/transfers of CPWD staff (like posting in the field or Planning Units) may be strictly followed. It may also be ensured that only those officers identified by CPWD for being transferred back to CPWD, are relieved accordingly and no one else.



- (ii) As regards recording of ACRs of the staff posted in Delhi PWD, it may not be necessary and practicable to have dual Reviewing Authority for recording ACRs of Superintending Engineers. The ACRs of Superintending Engineers can be initiated by the Chief Engineer concerned who has actually seen the work for not less than three months and then further be reviewed by the Engineer-in-Chief. The Principal Secretary, PWD, Delhi, the next superior officer can be the counter-signing authority. Similarly in the case of Chief Engineers working in PWD of Delhi, the ACRs can be recorded and reviewed by Engineer-in-Chief and Principal Secretary, PWD, Delhi respectively. Thereafter, Chief Secretary, Government of NCT of Delhi, the next superior officer in the hierarchy may be the counter-signing authority instead of DG (Works), CPWD.
- (iii) Regarding delegation of disciplinary powers in respect of CPWD engineers posted to the Government of Delhi, it may be stated that disciplinary powers in respect of Group 'C' & 'D' staff of CPWD already vest with SEs and Executive Engineers. However, in the case of Group 'B' staff, DG (Works) is the appointing authority. This Ministry is separately considering the issue regarding delegating the disciplinary authority powers to the concerned Additional Director General and Engineer-in-Chief, Delhi PWD in respect of concerned Group 'B' staff of CPWD for imposition of certain minor penalties.
