ORDER OF DEBARMENT

It is for the information of all concerned that M/s Detective and Security Service, RZ D-68, Gali No. 4, Mahavir Enclave, Palam Road, Dwarka, South-West, Delhi-110045, had participated in E-tendering process of work "A/R & M/O various road under Division WR-1, New Delhi during 2021-22 (SH.: Providing Services of Outsourcing Staff like Computer/Data Entry Operator, Clerical, Multitasking (MTS) and Housekeeping Staff under Sub Division WR-11, 12, 13, 14 & 15, Division WR-1, Control Room, E-in-C office, Circle office)."

Non Submission of Performance Guarantee and withdrawal of tender

The tender for above mentioned work has been called by Executive Engineer, West Road Division-1 with NIT No. 2/EE/PWD/WR-1/2021-22 and PG letter issued to M/s Detective and Security Service vide letter No. 54 (552)/PWD/WR-I (NCTD)/A-1/2021-22/1076 dated 11-06-2021 on their tendered amount of Rs. 70,61,870/-. But M/s Detective and Security Service vide letter No. D&SS/PWD/GNCTD/2021/06/14 dated 14-06-2021 has informed that **"We have been awarded the above mentioned work tender, however we are not in a position to accept this work tender because of the very low price quoted by us by mistake. It is not possible for us to accept this work order at such a low price quoted mistakenly by us."**

In response to M/s Detective and Security Service's letter dated 11-06-2021, Executive Engineer, West Road-1 has informed that in reference to circular of DG, CPWD issued vide No. DG/CON/Misc./13 dated 23-11-2020 wherein tenderer are exempted from depositing EMD while uploading tender in PWD/CPWD and in lieu of this exemption, the tenderer has to give declaration that they will be suspended for one year from tendering in PWD/CPWD, if they withdrawn from tender/modify condition/fail to deposit performance guarantee after opening of tender.

M/s Detective and Security Service is found guilty for non submission of performance guarantee, therefore M/s Detective and Security Service, RZ D-68, Gali No. 4, Mahavir Enclave, Palam Road, Dwarka, South-West, Delhi-110045 is debarred from tendering/taking up work in PWD (Govt. of Delhi.), CPWD all over India for a period of 01(One) year with effect from date of issue of this order or till further orders whichever is earlier.


