- 1. It has been observed that a number of unserviceable Govt vehicles, are pending for either condemnation or disposal in terms of GFR 2017, in various PWD divisions.
- 2. Non disposal of condemned vehicles in time leads to deterioration of the condition of the vehicle and thereby chances of getting better prices reduced. Moreover, large space is occupied by these condemned vehicles in parking spaces.
- 3. Finance Department, Govt of NCT of Delhi has engaged MSTC Ltd, A Govt of India Enterprise for undertaking the disposal of unserviceable articles including condemned vehicles. The Divisions are only required to provide the list of unserviceable vehicles to MSTC so as to enable them to take action for the disposal of the unserviceable vehicles. A copy of circular in this regard is enclosed herewith.
- 4. All the Executive Engineers/Superintendent Engineers are therefore advised to initiate immediate action for the disposal of condemned vehicles immediately and furnish a report in this regard in the following format within a week.

Subject: Details of condemned vehicles but not yet auctioned.

It has come to the notice of Finance Department that the Departments of GNCT of Delhi have obtained the approval of the competent authority to condemn the vehicles and purchased new vehicles against the condemned one, but the condemned vehicles has not yet been disposed off in terms of GFR, 2017.

- 2. Non-disposal of condemned vehicles in time leads to deterioration of the condition of the vehicle and thereby chances of getting better prices reduce. Moreover, large space is occupied in almost all the departments by these condemned vehicles.
- 3. Finance As Department's O.M. No.F.13/2/2010-AC/dsfa/dsIII/731-732 dated 06.08.2010, MSTC Ltd., a Government of India Enterprise, has already been engaged for undertaking the disposal of surplus or obsolete or unserviceable articles of all the Departments of Government of NCT of Delhi. MSTC Ltd. would act as Selling Agent for disposal of all items by way of e-auction over the Internet through <u>www.mstcecommerce.com</u>. They would arrange publicity for disposal through e-auctions by way of occasional advertisement in leading dailies/newspapers/websites and other Internet tools. The Departments are only required to provide the list of obsolete/surplus/unserviceable materials with detailed specifications and description, location, quantity, quality, etc. to MSTC so as to enable them to take action for the disposal. As per FD's letter of even number dated 07.01.2020, the Selling Agency Agreement with MSTC Ltd. has been extended up to 05.08.2022.
