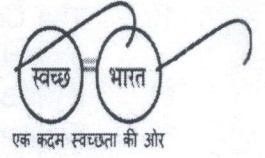

अप्रेषित प्रारंभिक प्राक्कलन के संदर्भ में उपर्युक्त कार्य के लिए रु० 7,20,09,569/- (रुपये सात करोड बीस लाख नौ हजार पाँच सौ उनहत्तर केवल) की प्रशासनिक अनुमोदन एवं व्यय स्वीकृति निम्नलिखित शर्तों पर सम्प्रेषित की जाती है:-

1. That Executive Engineer shall only be responsible for observing all codal formalities as per GFR and CPWD Works Manual while awarding the work and the release of payments.
2. The Expenditure involved is debitible to the Major Head "**5054-04-337-890053 Construction of Subways**" from within the sanctioned budget allotment subject to availability of funds.
3. That no escalation in cost or additional amount will be allowed in any case.
4. That the work shall be completed within the stipulated time-frame and within the sanctioned cost.
5. A completion report/certificate will be furnished to the office immediately after the work is completed and after making the entry in the relevant records.
6. A/A & E/S issued is purely on the basis of proposal submitted by the Executive Engineer (F-31). The Executive Engineer shall be responsible for execution of items-quantity, rate and its technical specification.
7. The Executive Engineer and /or Construction agency must not change the scope of work in any manner without approval of competent authority.
8. Engineer-in-Charge/construction agency may identify the probable impediments in the execution of projects well in advance and may project contingent measures/plans as identified to deal with them, so as to ensure completion of the projects as per approved time schedule.
9. Work completion certificate and copy of the 3rd party Quality Control Certificate, if applicable, may be furnished to this office.

10. The Construction agency shall submit the final bill reporting utilization of funds, completion of project and settlement of advance / deposit money on the completion of the work/project.
11. It will be ensured that all the payments to contractors made through electronic fund transfer only.
12. Tender shall be processed by way of e-tendering only.
13. No expenditure from Non-Plan head shall be incurred in respect of the maintenance of the aforesaid work during the period of maintenance contract with the Contractor.
14. The provision made for each of the drain/signages/electrical/horticulture, as applicable, shall be utilized for the specified purpose only. Inter-change of provision shall not be restored to.
15. The proposal is subject to fulfillment of guidelines/instruction/rules issued in this regard and compliance of GFR-2017.
