
The sanction is subject to the following conditions:

2. The monthly financial & physical progress report should be submitted regularly to the Vice Chancellor (NSUT) and Joint Director (Planning)-TTE).

3. The progress for execution of work will be reviewed and monitored by a constituted committee by DTTE on the basis of monthly progress report. The Vice Chancellor, NSUT may be consulted for any academic norms.
4. The project shall be completed as per approved scope of work within scheduled period at the sanctioned cost. No cost escalation will be considered in future & completion certificate must be furnished to the Joint Director (Planning), Department of Training & Technical Education, Delhi and Vice Chancellor (NSUT).
5. The tender shall be invited as per the approved cost considered on the recommendation of the department.
6. Compliance of pre-sanction/ post sanction guidelines/ requirement circulated as Annexure to Government order No. PA/ DSF/ Misc/ 2012-13/ Exp-4/ 538-45 dated 17-05-2012 during planning and execution period.
7. That total expenditure will not exceed the budget allocation under the specific sub-head during the financial year.
8. All Codal formalities will be observed as per CPWD Manual by the executive agency along with compliance of guidelines issued by Finance Department from time to time and order no. F.8/3/2010-AC/ usfa/ 41-44 dated 12-03-2015 (for DFPR 2015) and other guidelines issued from CVC/ DTTE/ FD/ IT Department from time to time.
