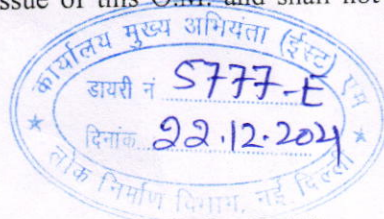
Whereas, lender has been invited online for NIT No. 48/EE/KKD Court Divn/PWD/NIT/2021-22 & tender ID No. 2021_PWD_211212_1 for the work of EOR to Govt. Girls Senior Secondary School, Jhilmil Colony, Delhi SH : Making Barrier Free Environment & White-Wash of the School Building at GGSSS, Jhilmil Colony, Delhi by this Division on 18th November, 2021.

Whereas, the above tender was opened on 01st December, 2021 in which the agency M/s Om Builders (Proprietor Nisha Gupta) r/o C-274, DDA Flats, East of Loni Road & Ground Floor, B-826, Block-B, MIG DDA Flats, East of Loni Road, Delhi – 110093 E-mail ID : ombuilders@gmail.com Mobile No. : 9643021232 was found lowest bidder (L-1). This non-CPWD agency has signed the declaration and submitted it in lieu of EMD which states as “I/we fail to sign the contract, or to submit performance guarantee before the deadline defined in the tender documents”, I/we shall be suspended for one year and shall not be eligible to bid for CPWD/PWD, Delhi tenders from date of issue of suspension order {refer Performa for Earnest Money Deposit Declaration}.

Whereas, this declaration and its conditions were incorporated in the NIT on the basis of Ministry of Finance, Govt. of India, O.M. No. F.9/4/220 PPD dated 12/11/2020, CPWD O.M. No. DG/CON/Misc./13 dated 23/11/2020, GNCTD endorsement No. F.(22)/ Fin.(Estt.III)2020/dSIV/182 dated 25/11/2020 and PWD Circular/endorsement No. E-in-Office/PWD/Dir(W)/4341 dated 22/12/2020.

Whereas, the agency M/s Om Builders neither submitted the performance guarantee nor to shown willingness to execute the work.

Therefore, the agency M/s Om Builders (Prop. Nisha Gupta) is hereby suspended for one year from the date of issue of this O.M. and shall not be eligible to bid for CPWD/PWD tenders during this period.


