For fulfillment of the aforesaid requirements, Sr. Supervisory Officers/Engineer during the course of execution/maintenance shall carry out regular inspections and ensure that specifications regarding quality/ quantity and proportions/measurements thereof are being adhered to scrupulously.

This approval has been accorded in exercise of the powers delegated by the Finance Department, Govt. of NCT Delhi and in consultation with the accounts functionaries of the department. The expenditure involved on the account is debitable to the Other Expenditure (Minor Head) Demand No.11, 4235 02 102 Child Welfare (Minor Head) 99 00 53 Implementation of Juvenile Justice Act,2000 (Sub Head).

Hence, the fund utilization certificate/work completion certificate shall be produced by PWD duly verified by the Ex. Engineer concerned/District Officer to office of the undersigned within one month from the date of completion of work as per stipulated time frame for the awarded / instant work.

- ❖ PWD should expedite the renovation work on an emergent basis so that new children can be admitted to the SAG before the next academic session.
- ❖ The work should be completed by the end of January-2022.


