In pursuance of the proposal of Executive Engineer (E), North-East & Shahdara Electrical Division, PWD, vide letter no. DB(19)/NE&Shah./M-251/2022/828 dated 20.05.22 and in-principal approval of the proposal by Pr. CE (M&F); I am directed to convey the Administrative Approval & Expenditure Sanction of Superintending Engineer, (Shahdara) PWD for carrying out the work "Supplying, Installation, Testing & Commissioning of 13 passenger Machine room lift at Vishwas Nagar, FOB, Delhi" for an estimated cost of Rs. 48,87,696/- (Rupees Forty-Eight Lakh Eighty Seven Thousand Six Hundred and Ninety Six Only) i/c @21.46% Cost Index, Less @9.50% on DSR Items (as per Govt. Delhi circular No. F. 8(2)/2007-AC/Finance/01295543/1376-1499 dt. 14.05.2018), @1% contingencies and @1% Labour Cess Leviable on PE as per financial powers delegated to Engineer officers of PWD Delhi for undertaking capital works vide Finance (infra) deptt. PWD No. 8(2)/2007-AC/Finance/01295542/JSFINA/1148-1166 dated 12.10.2017 subject to the following conditions:

- The Executive Engineer shall only be responsible for observing all codal formalities as per GFR and CPWD Works Manual while awarding the work and the release of payments. The EE shall also ensure that instruction of the Finance Department, GNCTD, GOI and CVC guidelines have been observed.
- The Expenditure involved is debitable to the Major Head 5054 "Improvement of Road Infrastructure" from within the sanctioned budget allotment subject to the availability of funds.
- 3. A/A & E/S are issued on the basis of the proposal submitted by the Executive Engineer. However, the detailed requirements such as items, quantities, technical specifications, feasibility, and necessity etc. shall be seen by the technical sanctioning authority i.e., the Executive Engineer.
- 4. No escalation in cost or additional amount will be allowed in any case.
- 5. The Executive Engineer should ensure that the plan funds are available in the Annual Plan 2021-22 for the above work.
- 6. The work shall be completed within the stipulated time-frame and within the sanctioned cost.
- A completion report/certificate will be furnished to this office immediately after the work is completed and after making the entry in the relevant records.
- 8. The Executive Engineer must not change the scope of work in any manner without the approval of the competent authority.

- 9. The Executive Engineer may identify the probable impediments in the execution of projects well in advance and may project contingent measures/plans as identified to deal with them, so as to ensure completion of the projects as per the approved time schedule.
- 10. The Executive Engineer shall submit the final bill reporting utilization of funds, completion of the project, and settlement of advance/deposit money on the completion of the work/project.
- 11. It will be ensured that all the payments to contractors will be made through electronic fund transfer only.
- 12. Tender shall be processed by way of e-tendering only.
- 13. No expenditure from the non-plan head shall be incurred in respect of the maintenance during the defect liability & maintenance period of the work.
- 14. EE should ensure that the guidelines/direction issued by the E-in-C vide no. E-in-C/Director/Work/DAC/PWD/2017/5093 dated 24.10.2017 (copy enclosed) should be complied with.
- 15. The Executive Engineer should ensure that the expenditure does not exceed the budget allocation.
- 16. Before making payment to the contractor the permission of HOD is required for expenditure sanction.
- 17. Copy of Premilitary Estimate approved by Circle office is enclosed.
