Office Memorandum

Sub: Requirement of experience by the Contractors for infrastructure works (Road Works).

1. As per office order of Govt. of NCT of Delhi vide No. Pr. CE (M)/PWD/W/E-Tend/3314 dated 08.06.2016, any Contractor fulfilling the requirement of work experience can participate in the tender of PWD for infrastructure/road works along with CPWD enlisted contractors in appropriate category.

Earlier as per rules for enlistment of Contractors in CPWD, the buildings and roads category were separate. The enlistment in the road category was being done on the basis of experience of the Contractor in the road work. The road work means any one or more of the following works:
"Construction of work including re-carpeting and road maintenance, bridges, flyovers, elevated road or rail corridor, road over bridge, foot over bridge, approaches of bridge or flyover, culvert, subway, underpass, tunnel, runway, sky-walk, river training work, other cross drainage works, etc."

2. Recently, the rule for enlistment of Contractor in CPWD, 2021 has been launched on 12.07.2021 in which building and road category has been created amalgamating building category and infrastructure category. For enlistment in this new category of Building and Roads, the experience of either building works or road works is valid. The Contractor having experience of building work can also be entitled for participation in tenders of road work. In such situation the eligibility of CPWD enlisted contractors in appropriate class will not hold good.
3. In the infrastructure category (road works), experienced firms/Contractors are required to participate in the tenders because if a Contractor is not experienced, then the construction work of flyover, bridge, tunnel, underpass etc. will be very difficult to execute at site. There are chances that inexperienced Contractors having enlistment in CPWD in B&R category on the basis of experience of only building works will start to participate in road work just to gain experience and progress will be suffered very badly.

Therefore, it is decided by the Hon'ble PWD Minister, GNCTD to keep the condition of requirement of experience in road works for all contractors including CPWD enlisted Contractors for Delhi PWD works excluding road repair/maintenance works costing upto Rs.4.00 Crores. This Office Memorandum supersedes the earlier OM issued vide No E-in-C/PWD/Works/00/2021/3251 dated 09.09.2021.
