**Subject: Non-performance of Private Sector Banks under PM SVANidhi Scheme - Blacklisting and withdrawal of Government Bank accounts from them.**

PM-SVANidhi was launched by Govt. of India on 01 June 2020, to provide immediate relief to the street vendors whose earnings have been adversely affected because of the nationwide lockdown w.e.f. March 2020. Many meetings have been held at various levels in last one year to impress upon the various private sector Banks to expedite the sanction and disbursement of loans under this scheme.

Over the past one year, the private sector banks have failed to live up to the expectations of the scheme, while in comparison all public sector banks have done exceedingly well.

It is clear from the figures alone that in spite of repeated appeal to the Private Sector Banks, they have shown apathy through failed in their performance in regard to this scheme meant for the poor and the marginalized sections of the society.

Therefore, I am hereby directed to convey the directions of the worthy Chief Secretary, GNCTD, that the following banks have been black listed by the Government of NCT of Delhi and all the ACS/ Pr. Secy./ Secretary/ HoDs of government departments and Commissioners/ MD/ CEOs of the autonomous corporations, including MCD must withdraw their bank accounts and deposits, if any, with the following top 4 defaulting banks, within a period of seven days:-


