Ministry of Jal Shakti (MoJS) launched "Jal Shakti Abhiyan - Catch The Rain 22" to make preparations for water conservation and recharge before the

onset of monsoon so as to maximize harvesting and utilization of rainfall during the monsoon.

The DJB has been nominated as State Nodal Agency for "JSA-CTR-2022". The last meeting of JSA was held on 19.7.2022, which was chaired by Secretary, Department of Water Resources and River Development and Ganga Rejuvenation, Ministry of Jal Shakti.

The activities related to Jal Shakti Abhiyan including IEC activities are being carried by respective departments. The departments are also required to inform their activities district wise to respective DMs. The activities are to be uploaded on Jal Shakti Portal of their respective districts.

In the last meeting presentation was desired in template. Copy of template is attached. The information is desired district wise.


