## OFFICE ORDER

Sub: Debarment for a period of One Year from e-procurement/e-tendering in CPWD/PWD in respect of M/S Richcon Engineering Company, 1/5100, Krishna Nagar, Dev Nagar, Karol Bagh, New Delhi-110005.

Whereas, tenders were floated vide NITs No. 30/EE/PWD/WR-I/2021-22, 31/EE/PWD/WR-I/2021-22, 32/EE/PWD/WR-I/2021-22, 33/EE/PWD/WR-I/2021-22 & 34/EE/PWD/WR-I/2021-22 for the work "A/R & M/O various roads under Division WR -1, New Delhi during 2021-22. (SH: Providing maintenance van for All Sub-Divisions) during the year 2021-22 by this office on 29.01.2022.

Whereas the agency has uploaded the experience certificate in e-procurement (tenders mention above) which has been issued by Municipal Corporation Guhawati, Assam vide their letter No. GER/CE/GMC/2018-19/96 dated 10.09.2018. This office has issued letter even no. 329 dated 07.02.2022 to the Chief Engineer (MI) Irrigation Department, Chandmari, Guhawati, Assam with request to verify experience certificate issued by them vide their no. GER/CE/GMC/2018-19/96 dated 10.09.2018.

In response to our letter, EE-VI the Municipal Corporation Guhawati, Assam, vide their letter even no. 2021 dated 24.02.22, has intimated that the "experience certificate uploaded by M/s Richcon Engineers Co. has not been issued by their office".

Whereas a notices has been issued vide this office letter even No.1696 dated 25.06.2022 to clarify the position and again this office issued notice vide 1752 dated 05.02.2022, but agency has not responded against the notice.

The agency has uploaded forged documents in above mentioned five NIT's.

The Chief Engineer(North), PWD has decided to debar M/s Richcon Engineers Co. for period of one year.

Therefore, the agency M/s Richcon Engineers Co. is hereby debarred/ suspended from e-procurement/e-tendering in CPWD/PWD for one year from the date of issue of this order.
