## **CIRCULAR**

Sub: Regarding PWD Web Portal Sarkai-Awas (sarkari-awas.delhi.gov.in).

Reference is invited to this department OM of even number dated  $29^{\text{th}}$  August, 2022 on the above subject matter. The followings are brought to the notice of all, as under:

- (i) The new web portal viz. <a href="www.sarkari-awas.delhi.gov.in">www.sarkari-awas.delhi.gov.in</a> has become operational w.e.f. 01/09/2022. However, it has been observed that very few users have registered/updated their profile in the Sarkari-Awas portal so far. The registration/ updation of profile in Sarkari-Awas portal is mandatory for being eligible to participate in ONLINE bidding process for allotment.
- (ii) To become eligible for participating in the ONLINE Bidding process for allotment of Govt residence, all the officers/officials have to complete two step process.

a) The first step is to get registered/update profile, in Sarkari-Awas portal.

b) Second step is to take the print out of registration form (DE-II Form) and get it verified from the Head of Office/DDO and forward the hard copy alogwith the required documents to Help Desk, Sarkari-Awas Cell, PWD Secretariat, 3<sup>rd</sup> Level, MSO Building, New Delhi, (preferably personally) for final approval in the Sarkari-Awas system. The verified and attested hard copy of the registration form (DE-II) alongwith required documents, is mandatorily required to be submitted in Sarkari-Awas Cell, PWD Secretariat, for approval in the Sarkari-Awas system, before the inception of ONLINE bidding process.

- (iii) It is further clarified that previously registered users of e-awas, are also required to update their profile on Sarkari-Awas portal. Further, the applicant has to take the print out of registration form (DE-II Form) and get it verified from the Head of Office/DDO and forward the hard copy alogwith the required documents to Help Desk, Sarkari-Awas Cell, PWD Secretariat, 3<sup>rd</sup> Level, MSO Building, New Delhi, (preferably personally) for final approval in the Sarkari-Awas system. It may be noted that without updating the profile on Sarkari-Awas portal, they would not be able to participate in the upcoming bidding process.
- (iv) It is also brought to the notice of all eligible users that vacant houses located in Greater Kailash, New Delhi area would also be available for ONLINE bidding/allotment.
