Sub: Suspension of Non-CPWD agency M/s Armour Security (India) Pvt. Ltd. for one year.


Whereas, tender was floated vide NIT no. 18/CE(OP)/PWD/2021-22 for the work of "Providing Clerical, Multitasking and Housekeeping Staff-Un-skilled, Semi-skilled, Clerical and Non-Technical Supervisory Staff in various offices under Chief Engineer (OP), PWD, GNCTD, New Delhi during the year 2021-22" by this office on 16-09-2021.

Whereas, the above tender was opened on 23-09-2021 in which the agency M/s Armour Security (India) Pvt. Ltd. Proprietor Shri Vinod Gupta, B-87, Defence Colony, New Delhi-110024 was found lowest bidder. This non-CPWD agency has signed the declaration and uploaded it in lieu of EMD which states that if I/we withdraw or modify my/our bid during the validity period of the tender (i.e. 30 days in this case), I/we shall be suspended for one year and shall not be eligible to bid for CPWD/PWD tenders from date of issue of suspension order.

Whereas, this declaration and its conditions were incorporated in the NIT on the basis of Ministry of Finance OM No. F.9/4/220 PPD dated 12-11-2020. CPWD OM No. DG/CON/Misc./13 dated 23-11-2020, GNCTD endorsement No. F(22)/Fin.(Estt.III)2020/dSIV/ 182 dated 25-11-2020 and PWD Circular endorsement No. E-in-office/PWD/Dir(W)/4341 dated 22-12-2020.

Whereas, the agency has shown unwillingness to execute the work and withdrew his bid after opening of tender vide their letter no. nil and received in this office on 04-10-2021.

Therefore, the agency M/s Armour Security (India) Pvt. Ltd. is hereby suspended for one year from the date of issue of this OM and shall not be eligible to bid for CPWD/PWD tenders during this period.


