CIRCULAR

An incident of paper leakage/cheating was reported by Flying Squad Team during all India Trade Test Exam, under Craftsman Skill Scheme (CTS) conducted by National Council for Vocational Training (NCVT) on 02.08.2019 at ITI Shahdara.

Further the said matter was received in this Directorate on 30.12.2020 for placing before the disciplinary authority for initiation of disciplinary proceedings against the erring officers of the said incident. The said proposal was examined in this Directorate and found incomplete in respect of documents etc. and accordingly clarification was sought from the concerned administrative department.

The matter was placed before the disciplinary authority on 20.11.2021 and Hon'ble L.G., Delhi has expressed displeasure for inordinate delay between the date of misconduct and submission of the matter before him for seeking approval of initiation of Disciplinary Proceedings against the erring officers and directed all the HODs to review all pending cases at least once in a month to avoid such type of delay.

Accordingly, all the Additional Chief Secretaries / Pr. Secretaries / Secretaries / HODs, Govt. of NCT of Delhi are requested to ensure the compliance of the order of Hon'ble Lt. Governor and to review all pending disciplinary proceedings / vigilance cases at least once in every month to avoid delay in Vigilance work.
