Consequent upon issuance of Modified Revised Estimate 2022-23 by Finance (Budget) Department, GNCTD uploaded in the web site of Finance Department, GNCTD Director (works), Public Works Department, GNCTD reallocated Modified RE to all the Pr. Chief Engineers/Chief Engineer of various zones.

- 2. Based on the re-allocation by Director (Works), PWD, the Pr. Chief Engineer/ Chief Engineers of various zones except Other Projects Zone has distributed the budget to various divisions as per Modified Revised Estimates.
- 3. Further instances have been observed during the previous years, that frequent modifications in most Head of Accounts are made by the Pr. Chief Engineer/Chief Engineer even after distribution of Modified Revised Estimates. These kinds of modifications lead to chances of excess LOC against budget allotment.
- 4. It is, therefore, requested to direct the Pr. Chief Engineer/Chief Engineer of all zones of PWD to re-distribute/revise the budget to various divisions as per Modified Revised Estimates latest by 03:00 P.M. of 30.03.2023 and all the divisions of PWD should apply for LOC latest by 05:00 P.M. of 30.3.2023 as the Current Financial Year is on the verge of closing. Further, it is also informed that further modifications in the budget of Divisions received in this Office after 03:00 PM of 30.3.2023 and letters for issue of LOC from Divisions received in this Office after 05:00 PM of 30.3.2023 may not be considered for issuance of LOC.
- 5. The above said instructions may please be brought to the notice of all Pr. Chief- Engineers/ Chief- Engineers/Executive Engineer/Dy. Director (Hort.) concerned for strict compliance.
