With reference to the U.O. Note No. 23(DFPR)/E-in-C/PWD/2019-20/5826(E) dated 05/11/2019 of E-in-C, PWD regarding Review of standing order of Hon'ble Minister (PWD) dated 27/08/2019, the matter was taken up with the Hon'ble Minister (PWD) in consultation with Finance Department, GNCTD.

Hon'ble Minister (PWD) has superseded his Standing order dated 27/08/2019 on the subject cited above and issued a new Standing order dated 11/12/2019 (page 1/C) wherein it has been conveyed that:-

"In supersession of Standing Order No. Minhealth/2019/5293-99 dated 27/08/2019, it is hereby ordered that in case of every work/scheme of Rs. 1.0 crore each and above, the authority who is competent to accord AA/ES, will also get the work/scheme approved from the undersigned directly before according AA/ES."

Now, as per Hon'ble Minister (PWD) new standing order dated 11/12/2019, financial power shall be exercised by the competent authorities i.e. HODs/Administrative secretaries, as mentioned in the Finance Department's OM dated 07/08/2019 and only proposal may be shown to the Hon'ble Minister (PWD) by the competent authority before according AA/ES.

In view of above, if agreed and approved, E-in-C, PWD may be requested to process the proposals for seeking A/A & E/S in accordance with the Finance Department's OM dated 07/08/2019 and before according A/A & E/S, and only proposal may be shown to the Hon'ble Minister (PWD) by the competent authority before according AA/ES in the cases of above Rs 1 crore and upto Rs 10 crore.

Further, in the case of proposals above Rs 10 crore and upto Rs 50 crore, before sending the same to PWD Secretariat, E-in-C, PWD may ensure that:-

- PE has been prepared on the basis of DSR-2016 as per instructions of Finance Department, GNCTD dated 14/05/2018.
- 2. The proposals have been properly examined by the Engineering wing, PWD and accounts functionary/Finance officer of PWD confirming the availability of funds and correctness of the PE.
- Attach all the relevant documents i.e. Budget allocation for the proposed respective work, preliminary estimate, BBD test report, carried out by the third party, UTTIPEC recommendation, if applicable etc.

File should be send with proper paragraph numbering/paging, all overwri_gs/cuttings and each page should be attested by the concerned Executive Engineer.

5. Enclose copy of Google map with proper marking i.e. Length, Starting and Ending point of the proposed work.

Accordingly, the file may be forwarded to the E-in-C, PWD for information and necessary action.
