Whereas M/s Aliyan Construction Co. was a registered contractor in CPWD, Class-I (Buildings & Roads) category was originally valid up to 26.12.2021 and which was extended upto 30.06.2022.

Whereas the M/s Aliyan Construction Co. was awarded the following work in PWD, GNCT Delhi:-

1. EOR to 650 bedded of DDU Hospital at Hari Nagar, New Delhi. (SH: Renovation/ Upgradation of Ward 1, 2, 3 & 4. for Civil and E & M works.) Agreement No. 09/EE/HSW M-123/PWD/2020-21

Whereas M/s Aliyan Construction Co. has failed to execute/ complete the above work.

Whereas the Executive Engineer, Health Maintenance Division (S-W), M-123, PWD, DGER Complex, Sector-3, Dwarka, New Delhi - 110078 has determined the above work under clause-3 vide letter no. 54(9)/ले.शा./स्वा0अन्0मं0 (द0-प0)/एम-123/लो0नि0वि0/773 dated 28.04.2022.

Whereas a show cause notice was issued to M/s Aliyan Construction Co. vide letter No. 25(13)/ADG(PD)/2022/4111 dated 19.12.2022 to explain the reasons for breach of provisions of enlistment rules 2022. The show cause notice was replied by M/s Aliyan Construction Co. vide letter No. Nil dated 29.12.2022.

Whereas the reply submitted by M/s Aliyan Construction Co. vide letter dated 29.12.2022 along with the documents submitted by the concerned Executive Engineer, PWD, Delhi and the recommendations of Engineer-in-Chief, PWD, Delhi were examined by the Empowered Committee.
