Office Order

Sub.: Disciplinary action against contractor – A.S. Infratech -regarding.

Whereas A.S. Infratech is a registered contractor in CPWD, Class-I (Buildings & Roads) category having validity of enlistment up to 19.04.2027.

Whereas the A.S. Infratech was awarded/ tendered for the following works in PWD, GNCT Delhi:-

- 1. Strengthening / Raising of Road, Raising Central Verge, both sides of drain and footpath to prevent water logging on the road BDO office to Goyla Morh Najafgarh-Bijwasan Road (ID 1173) under Sub Division-5, South West Road-II, PWD, New Delhi.

- 2. Construction of slip road in front of Gurudwara Majnu Ka Tila at road No. 45 under Sub Division-1 of Division C&ND-Roads, New Delhi. 1st Recall.

Whereas A.S. Infratech has failed to execute/ complete the work at Sl. No. 1 and the Executive Engineer, South-West Road-II, PWD, GNCT Delhi, Under Dabri flyover, Pankha Road, New Delhi has determined the work, under clause-3 vide letter no. 54(01)/PWD/SWR-2/2021-22/1284 dated 25.08.2021.

Whereas A.S. Infratech vide letter dated 16.04.2022 showed his inability to execute the work at Sl. No. 2 and their 100% EMD was forfeited by Executive Engineer, C&ND Road Division(M-413), Opposite IGI Stadium New Delhi - 110002 vide letter no. 54(1361)/EE/C&ND-R/PWD/20-23/752 dated 19.04.2022.

Whereas a show cause notice was issued to the contractor vide letter No. 25(13)/ADG(PD)/2022/4044 dated 09.12.2022 to explain the reasons for breach of provisions of enlistment rules 2022. The show cause notice was replied by A.S. Infratech vide letter No. Nil dated 18.01.2023.

Whereas the reply submitted by A.S. Infratech vide letter dated 18.01.2023 along with the documents submitted by Executive Engineer, PWD, Delhi and recommendations of Engineer-in-Chief, PWD, Delhi were examined by the Empowered Committee.

Whereas, based on the above mentioned facts and records, the Empowered Committee found that A.S. Infratech has failed to execute/ complete the work at Sl. No. 1 and has become liable for disciplinary action. Therefore, the Empowered Committee has recommended for debarment of contractor in terms of rule No. 13.7 of ER-2022.

And therefore, based on the recommendations of the Empowered Committee, the Enlisting Authority is pleased to debar A.S. Infratech, B-37, Ashok Vihar, Phase-I, New Delhi 110052 an enlisted contractor of CPWD under Class-I, B&R Category for a period of **06 (six months)** for tendering in CPWD from the date of issue of this order.
