Whereas Sh. Pratap Singh has failed to execute/ complete the above work.

Whereas the Executive Engineer, North-East Building & Road Maintenance Division, PWD, Shastri Park, Delhi – 110053 has determined the above mentioned work under clause-3 vide letter no. 54(1048/PWD/NE/(B&R)MD/1668 dated 27.05.2022.

Whereas a show cause notice was issued to the contractor vide letter No. 25(13)/ADG(PRD)/2022/3775 dated 16.11.2022 to explain the reasons for breach of provisions of enlistment rules 2022. The show cause notice was replied by Sh. Pratap Singh vide letter No. PWD/M-213/Notice/201 dated 23.11.2022.
