Sub.: Disciplinary action against contractor – M/s The Unique Enterprises -regarding.

Whereas M/s The Unique Enterprises is a registered contractor in CPWD, Class-I (Buildings & Roads) category having validity of enlistment up to 14.12.2025.

Whereas the M/s The Unique Enterprises was awarded the following work in PWD, GNCT Delhi:-

1. **Strengthening of Ghitorni Village Road (Zero Road) under Sub-Division SR-15, Division South Road-1 at New Delhi
Agreement No.: 09/EE/PWD/RMD/SR-1/2021-22.**

Whereas M/s The Unique Enterprises has failed to execute/ complete the above work.

Whereas the Executive Engineer, Division South Road-1, PWD, GNCT Delhi, Sukhdev Vihar, Mathura Road, New Delhi - 110025 has determined the above work under clause-3 vide letter no. 54(468)/EE/DSR-1/PWD/2021-22/1943 dated 18.11.2021.

Whereas a show cause notice was issued to the contractor vide letter No. 25(13)/ADG(PRD)/2022/3663 dated 03.11.2022 to explain the reasons for breach of provisions of enlistment rules 2022. The show cause notice was replied by M/s The Unique Enterprises vide letter No. TUE/1/22-23 dated 18.11.2022.


Whereas the reply submitted by M/s The Unique Enterprises vide letter dated 18.11.2022 along with the documents submitted by the concerned Executive Engineer, PWD, Delhi and the recommendations of Engineer-in-Chief, PWD, Delhi were examined by the Empowered Committee.

Whereas, based on the above mentioned facts and records, the Empowered Committee found that M/s The Unique Enterprises has failed to execute/ complete the above work and has become liable for disciplinary action. Therefore, the Empowered Committee has recommended for debarment of contractor in terms of rule No. 13.7 of ER-2022.

And therefore, based on the recommendations of the Empowered Committee, the Enlisting Authority is pleased to debar M/s The Unique Enterprises, C-3/59, Phase-2, Ashok Vihar, Delhi – 110052 an enlisted contractor of CPWD under Class-I, B&R Category for a period of **06 (six) months** for tendering in CPWD from the date of issue of this order.


