Office Order

Sub.: Disciplinary action against contractor – M/s S S Chauhan & Sons -regarding.

Whereas M/s S S Chauhan & Sons is a registered contractor in CPWD, Class-I (Buildings & Roads) category having validity of enlistment up to 19.10.2026.

Whereas the M/s S S Chauhan & Sons was awarded the following works in PWD, GNCT Delhi:-

1. A/R & M/O to various roads under PWD Division South West Road-1 during 2020-21. SH: Improvement of Footpath and Construction of Boundary Wall at New RTR Flyover under Sub Division-1.
Agreement No.: 04/EE/SWR-1/PWD/2021-22.
2. A/R & M/O to various roads under PWD Division South West Road-1 during 2020-21. SH: Construction of Footpath and Misc. Works at NH-8 Slip towards Dwarka approach road under Sub Division-1, New Delhi.
Agreement No.: 17/EE/SWR-1/PWD/2021-22
3. Restoration of Road on Arya Samaj Road from Dayal Chowk to Elahi Bux Road by DTL Agency under PWD Division South West Road-1 during 2020-21 under Sub Division-III.
Agreement No.: 18/EE/SWR-1/PWD/2021-22
4. Road restoration cut by STPL and various agencies at Subroto Park to RTR Marg on Outer Ring Road under PWD Division South West Road-1 during 2020-21 under Sub Division-1.
Agreement No.: 20/EE/SWR-1/PWD/2021-22
5. A/R & M/O to various roads under PWD Division South West Road-1 during 2020-21. SH: Repair of drain and improvement of footpath and road of Guru Ravi Dass Marg from Tikona Park to Tank Road in WEA Karol Bagh area under Sub Division-III.
Agreement No.: 21/EE/SWR-1/PWD/2021-22

Whereas M/s S S Chauhan & Sons has failed to execute/ complete all the above five works.

Whereas the Executive Engineer, South-West Road-1, PWD, GNCT Delhi, Brar Square, New Delhi - 110010 has determined the **above mentioned five works** under clause-3 vide letters even No. 1718 H, 1720 H, 1694 H, 1717 H and 1695 H dated 19.08.2021, 19.08.2021, 18.08.2021, 19.08.2021 and 18.08.2021 respectively.

Whereas a show cause notice was issued to the contractor vide letter No. 25(13)/ADG(PD)/2022/3996 dated 05.12.2022 to explain the reasons for breach of provisions

of enlistment rules 2022. The show cause notice was replied by M/s S S Chauhan & Sons vide letter No. Nil dated 16.12.2022.

Whereas the reply submitted by M/s S S Chauhan & Sons vide letter dated 16.12.2022 along with the documents submitted by PWD, Delhi and recommendation of Engineer-in-Chief, PWD, Delhi were examined by the Empowered Committee.

Whereas, based on the above mentioned facts and records, the Empowered Committee found that M/s S S Chauhan & Sons has failed to execute/ complete all the above five works and has become liable for disciplinary action. Therefore, the Empowered Committee has recommended for debarment of contractor in terms of rule No. 13.7 of ER-2022.

And therefore, based on the recommendations of the Empowered Committee, the Enlisting Authority is pleased to debar M/s S S Chauhan & Sons, 304, Surya Complex, 21 Veer Savarkar Block, Shakarpur, Delhi-110092 an enlisted contractor of CPWD under Class-I, B&R Category for a period of **09 (nine) months** for tendering in CPWD from the date of issue of this order.
