**OFFICE MEMORANDUM**

**Sub: Grant of financial upgradation under MACP Scheme to Junior Engineers holding higher post of Assistant Engineers (Civil & Elect.) on Ad-hoc basis....regarding**


The undersigned is directed to refer to the subject mentioned above. In this regard, it is stated that as per the DoPT's guidelines the MACP is admissible at 10, 20 and 30 years from the direct entry grade or 10 years of continuous service on regular grade/promotion. Thus, adhoc promotion is not counted under MACP Scheme as in case of 10 years of continuous service in a grade.

2. Further, it is illustrated vide Para 27 (A)(i) of DoPT OM dated 22/10/2019 that :

*"If a government servant gets his 1st regular promotion on completion of 8 years of service and then continues in the level for further 10 years without any promotion then he would be eligible for 2nd financial upgradation in next level (after completion of (8+10)18 years)."*

3. In view of the above, it is requested to revise/re-examine/withdraw the MACP cases in respect of all officers who have been inadvertently granted the 2nd financial upgradation on completion of 10 years from their **ad-hoc promotion** in a grade under intimation to this Directorate.
